AND WHEREAS, the Governor of Balochistan is satisfied that circumstances exist which render it necessary to take immediate action:

NOW THEREFORE, in pursuance of Article 4 of the Provisional Constitution (Amendment) Order, 1999 (Chief Executive's Order No.9 of 1999), and in exercise of all powers enabling him in that behalf, the Governor of Balochistan is pleased to make and promulgate the following Ordinance:-

Short title and I. (1) This Ordinance may be called the Provincial Motor Vehicles commencement. (Second Amendment) Ordinance,2001.

(2) It shall come into force at once and shall be deemed to have / taken effect on 23" day of April.2001.

#### **ALTERATION/CONVERSION OF VEHICLE**

8. Any alteration warranting change in the "Description of Vehicle" recorded in this certificate,

shall be notified to the concerned MRA for necessary amendments in the certificate of  
registration and associated office records.

#### **NUMBER PLATES**

16. Loss or destruction of both the number plates of the vehicle shall be notified to the police and the matter published in daily news paper. A copy of police report and the cutting of the news paper together with an affidavit, a copy of NIC of the owner and an application shall be produced before the concerned MRA for issuance of new number plates on payment of cost prescribed.

11. In case of loss or destruction of any of the two number plates. the same shall be notified to

the police and an application together with the copy of police report, an affidavit and copy of NIC of the owner along with the remaining number plate(s) shall be produced before the concerned MRA for issuance of new number plates on payment of cost prescribed.

#### CHANGE OF ADDRESS

Any change in the address of the owner/keeper shall have to be notified together with the certificate of registration and prescribed fee within 30 days of such change of address to the concerned MRA i.e. the authority with which the vehicle is registered or the authority in whose jurisdiction the new address falls for necessary endorsement in the certificate of registration under intimation to the original MRA who shall make necessary corrections in his record also.

#### CHANGE OF OWNERSHIP

In case of transfer of ownership of the motor vehicle the transferee shall, within 30 days of such transfer shall produce the certificate of registration, attested photo copy of NIC of seller and purchaser both along with the prescribed fee to the concerned MRA for the issuance of new certificate of registration.

#### TRANSFER TO ANOTHER DISTRICT/PROVINCE

. When a vehicle is removed to other District/Province, the owner shall on the expiry of 12 months of the removal of the vehicle, surrender the certificate of registration, number plates together with No Objection Certificate (NOC) of the original MRA, attested photocopy of NIC of the owner along with the prescribed fee to the new MRA, who upon verification of documents from the concerned quarters shall issue new registration mark and number plates.

. The number plates so surrendered shall be destroyed by the MRA assigning new registration mark, in its supervision under intimation to the original MRA.

#### TAX

. Motor vehicle tax shall be payable on yearly/half-yearly/quarterly basis in respect of all motor vehicles excluding Buses and Trucks in respect of which the same may be payable on quarterly basis or in the manner as may be prescribed by the government from time to time,

. Motor vehicles taxes and other fees shall be payable in the designated branches of NBP or the MRA offices or as may be notified by the government from time to time within the Balochistan province.

18. In case of vehicle falling under the category of "exemption". the owner/keeper/agency shall have to seek renewal of the certificate of registration before its expiry.

In case if vehicle is placed off the road and the owner desires to avail the exemption from Payment of tax. the owner shall within 15 days of commencement of non-use. deposit the certificate of registration. number plates. and insurance certificates. etc. of the vehicle with the concerned MR. mentioning the place of garage of such vehicle,

#### CAUTION

It shall be borne in mind that the certificate of registration and number plates are the Property of government, and that their proper maintenance and custody shall be primary duty of the owner/keeper of the vehicle.

#### PERMANENT DESTRUCTION/SCRAP OF THE VEHICLE

24. It shall be incumbent upon the owner/keeper of the vehicle to deposit the certificate of registration and the number plates etc. with the concerned MRA before disposal or handing over the vehicle to any agency/dealer in scrap. and shall obtain necessary certificate of clearance therefrom. Any failure in this behalf shall render the owner/keeper liable to criminal proceeding and when any misuse of the certificate of registration or number plates is reported or detected.

#### PHYSICAL INSPECTION OF THE VEHICLE

22. The applicant shall produce the vehicle before the MRA regarding non-commercial vehicles and for commercial vehicles to the Motor Vehicle Examiner (MVE) in case of registration. issuance of duplicate copy of certificate of registration or number plates, transfer of ownership or change of address etc. along with other required documents.
