WHEREAS, it is expedient further to amend
the Quetta Water and Sanitation Authority Act 2004
(Act.No. XII of 2004) for the purpose hereinafter

appearing;

It is hereby enacted as follows:

(1) _ This bill may be called the Quetta Water and
Sanitation Authority (Amendment)
Act, 2010.

(2) It shall com into force at once.

In the Quetta Water and Sanitation Authority Act
2004 (Act No. XII of 2004) hereinafter referred Of
to as the said Act, in Section 6 for the words
“Nazim Quetta City District Government” the
words “Minister WASA” shall be substituted.

In the said Act in Sectici 34 (1) the words “with
the prior approval of Provincial Government” of
appearing in first line shall be omitted.

In the said Act, for Section 36, the following shall

be substituted; “ 36 Whoever contravenes any provision of this Act or regulation or licenses made there under shall be punishable with imprisonment for a term which may extend to six months or with fine not exceeding Rupees five thousand or with both.”

In the said Act in Section 37 (1) and (2) for the words “five thousand ” the word “ ten thousand” shall be substituted respectively.
