WHEREAS, it is expedient to amend the Sardar Bahadur Khan Women's University Quetta Act, 2004 (Act No. IX of 2004) into the manner hereinafter to amend the Sardar Bahadur Khan Women's University Quetta Act, 2004 (Act No. IX of 2004) appearing;

Pro-Vice Chancellor of the University, who shall be appointed by

another term, and on such terms and conditions as the  
Chancellor may determine.
