ORDINANCE

further to amend the Societies Registration Act, 1860. in its application to the

Province of Balochistan,

WHEREAS it is expedient further to amend the Societies Registration Act. 1860 (NNTP of T1860). in its application to the Province of Balochistan for the purposes

hereinafter appearing:

AND WHEREAS the Provincial Assembly of Balochistan is not in session and the Governor of Balochistan is satisfied that circumstances exist which render it

Necessary to take immediate action:

NOW, THEREFORE, in exercise of the powers conferred by Article 128 of the Constitution of the Islamic Republic of Pakistan, 1973, the Governor of Balochistan is

pleased to make and promulgate the following Ordinance :-

I. Short title and commencement. (1) This Ordinance may be called the Societies

Registration (Baloghian Amendment) Ordinance, 2007,

to which shall come into force at once.

2 Amendment of section 21, Act XI of 1860. In the Societies Registration

Act P8600. for section 74, the following shall be substituted. namely:

"2t. Registration of Deeni Madaris. (1) Any Deeni Madaris by  
such a person called shall not operate without setting themselves registered as under.

a) The Deeni Madaris existing before the commencement of the Societies Registration (Balochistan Amendment) Ordinance, 2007 if not already registered. shall get themselves registered. under this

Act and

iy The Deeni Madaris which are established alter the commencement of the Societies Registration (Balochistan Amendment) Ordinance. 2007. shall get themselves registered within one year ef their

establishment.

Explanation:- One Deeni Maddrassah having more than one campus shall need only one registration

(2) Every Deeni Maddrassah shall) submit annual report ef its educational activities to the Registrar.

(3) Every Deent Maddrassah shall cause to be carried out audtt of its accounts by an Auditor and submit a copy of its audit report to the Registrar.

(4) No Deem Maddrassah shall teach or publish any titerature which promotes nulitaes er spreads seetaanism or religious Hatred:  
Provided that nothing contained herein shall bar the comparative studs ol

Various religious er school of thought or studs of any other subject covered bs the Hols Quran. Sunnah or fdanmiie purisprudence

Explanation: In this section \* Deeni Maddressah" means a\_ religious institution primarily for religious education and includes Jamia. Dar-ul-uloot > School. 2006 (IX of 2006), is hereby repealed.
