ORDINANCE, 1985

(Balochistan Ordinance I of 1985)

[14" January, 1985]

An Ordinance further to amend the Stamp Act, 1899 (II
of 1899), in its application to the Province of Balochistan.

WHEREAS it is expedient further to amend the Stamp
Act, 1899, in its application to the Province of Balochistan, in
the manner hereinafter appearing;

AND WHEREAS the Governor is satisfied that
circumstances exist which render it necessary to take immediate
action;

NOW, THEREFORE, in exercise of the powers
conferred by Article 128 of the Constitution, read with Article 2
of the Provisional Constitution Order, 1981 (C.M.L.A. Order
No. 1 of 1981), the Governor of Balochistan is pleased to make
and promulgate the following Ordinance: —

1. () This Ordinance may be called the Stamp
(Balochistan Amendment) Ordinance, 1985.

(2) It shall come into force on the 1“ day of January,
1985.

2. In the Stamp Act, 1899, after section 9, the following
new section shall be inserted, namely: —

“9-A. Power _of Provincial Government to _exempt_

certain instruments. — The Provincial
Government may, by notification in the official Gazette,
generally exempt from payment of the whole or any part
of the duties on any instruments executed by or in
favour of a banking company in the normal course of its
banking business.

Explanation. — For the purpose of this section,
“banking company” shall have the same meanings as
have been assigned to it in the Banking Tribunals
Ordinance, 1984’.”
