ORDINANCE, 1959

(W.P. Ord. XLVI of 1959)

[15" August, 1959]

An Ordinance further to amend the Stamp Act, 1899, in  
its application to the Province of \*[Balochistan].

WHEREAS it is expedient further to amend the Stamp  
Act, 1899, in its application to the Province of \*[Balochistan] in  
the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Presidential  
Proclamation of the seventh day of October, 1958, and in  
exercise of all powers enabling him in that behalf, the Governor  
of West Pakistan is pleased to make and promulgate the  
following Ordinance:—

1. This Ordinance may be called the Stamp (?[Balochistan]  
Amendment) Ordinance, 1959.
2. For sub-section (2) of section 1 of the Stamp Act, 1899  
(hereinafter referred to as the principle Act), the following sub-  
section shall be substituted, namely:-

"(2) It extends to the whole of the Province of  
?[Balochistan], except '[the Karachi Area and the Tribal  
Areas]'.

3. In clause (9) of section 2, section 9, sub-section (1) of section 10 and sections 16, 18, 33, 37, 49, 70, 74 and 75 of the principal Act, for the words "Collecting Government" the words "Provincial Government" shall be substituted.

4. Clause (12-A) of section 2 of the principal Act, shall be omitted.

This Ord. was promulgated by the Governor of W.P. on 10" August, 1959; published in the W.P. Gazette (Extraordinary), dated August, 1959, pages 753-54; saved and given permanent effect by Article 225 of the Constitution of the Islamic Republic of Pakistan (1962).

5. In the proviso to section 3, clause (a) of the first proviso to section 26 and clause (e) of the proviso to section 35 of the principal Act, for the words "the Crown" wherever occurring, the word "Government" shall be substituted.

6. In sub-section (3) of section 8 of the principal Act, for the word "Government" the words "Provincial Government" shall be substituted.

7. In section 76-A of the principal Act, the words, commas and figures "Central Government, subject to the provisions of section 24(1) of the Government of India Act, 1935, and the" shall be omitted.

8. In Schedule I to the principal Act—

(i) in article 53, in exemption (a), for the words "the

Crown", the word "Government", in exemption (d), for the words "His Majesty's", the word "Pakistan" and in exemption (f), for the words "the Crown", the word "Pakistan" shall be substituted; and

(ii) in exemption (e) to article 57 for the words "officers of the Crown", the words "servants of the State" shall be substituted.

Repeal. 9. The enactments specified in the Schedule and the amendments affected thereby are repealed to the extent specified in the fourth column of the Schedule.
