An Ordinance further to amend the Stamp Act, 1899? (II  
of 1899).

Preamble. WHEREAS, it is expedient further to amend the Stamp  
Act, 1899, in the manner hereinafter appearing;

AND WHEREAS, the Governor of Balochistan is  
satisfied that circumstances exist which render it necessary to  
take immediate action;

NOW, THEREFORE, in pursuance or Article 4 of the  
Provisional Constitution (Amendment) Order, 1999 and in  
exercise of all powers enabling him in that behalf, the Governor  
of Balochistan is pleased to make and promulgate the following

Ordinance:—

Short title and 1. (1) This Ordinance may be called the Stamp  
commencement. (Balochistan Amendment) Ordinance, 2002.

(2) It shall come into force at once.

Amendment of 2. In Schedule I of the Stamps Act, 1899°.

"10. ARTICLES OF ASSOCIATION OF  
COMPANY.

(a) Where the company has no\_ Fifty

**EXEMPTION.** Articles of any Association not formed for profit and registered under section 26 of the Companies Ordinance, 1984!.”

(2) For Article 39, the following shall be substituted: —

“39. MEMORANDUM OF ASSOCIATION OF A COMPANY

(a) If accompanied by Articles Seventy of Association under five section 35 of the Rupees

Companies Ordinance, 1984!.

(b) If not so accompanied. Two hundred Rupees

**EXEMPTION.** Memorandum of any association not formed for profit and registered under section 26 of the Companies Ordinance, 1984!.”
