ORDINANCE, 1979

(Baluchistan Ordinance I of 1979)

[28th January, 1979]

An Ordinance to amend the Succession Act, 1925
(XXXIX of 1925) in its application to the Province of
Baluchistan.

Preamble. WHEREAS it is expedient to amend the Succession Act,
1925, (XXXIX of 1925) for the purpose hereinafter appearing;

AND WHEREAS the Governor is_ satisfied that
circumstances exist which render it necessary to take immediate
action;

NOW, THEREFORE, in pursuance of the Proclamation
of the fifth day of July, 1977^o, read with the Laws (Continuance
in Force) Order, 1977 (CMLA Order No. 1 of 1977), and in
exercise of all powers enabling him in that behalf, the Governor
of Baluchistan is pleased to make and promulgate the following

Ordinance: —

Short title, extent 1. (1) This Ordinance may be called the Succession
and (Baluchistan Amendment) Ordinance. 1979.
commencement.

(2) It shall come into force at once.

Amendment in 2. In clause (bb) of Section 2 of the Succession Act, 1925,
Section 2 of Act after the word 'jurisdiction' the following words shall be added.
XXXIX of namely: —

1925.

"and shall be deemed to include the Presidents of Majlis-
e-Shoora in Kalat and Khuzdar Civil Districts"

This Ordinance, which amended Succession Act, 1925 (Act XXXIX of 1925), was promulgated by the Governor of Baluchistan
on 21st January, 1979; published in the Baluchistan Gazette (Extraordinary) No. 8, dated 28th January, 1979. Saved and validated
by Article 270-A of the Constitution of the Islamic Republic of Pakistan (1973).

Spelling of the word "Baluchistan", wherever it appears in this ordinance, is corrected by insertion of letter "o" instead of "u"; as
