'THE UNIVERSITY OF BALOCHISTAN ACT, 1996

(Balochistan Act No. III of 1996)

[27 May, 1996]

An Act to re-constitute and re-organize the University of Balochistan;

Preamble. WHEREAS it is expedient to re-constitute and re-organize the University of Balochistan for the purpose of promoting the advancement and dissemination of knowledge in the Province of Balochistan;

It is here by enacted as follows:—

CHAPTER — I  
PRELIMINARY

Short title and 1. () This Act may be called the University of Commencement. Balochistan Act, 1996.

(2) It shall come into force at once.

Definitions. 2. In this Act and in all the Statutes, the Regulations and the Rules made here-under, unless there is anything repugnant in the subject or context,-

(a) "Academic Council" means the Academic Council of the University;

(b) "Affiliated College" means an \_ educational institution affiliated to the University but not maintained or administered by it;

(c) "Authority" means the Authorities of the university specified in section 18;

(d) "Chancellor" means the Chancellor of the University;

(e) "College" means a constituent college or an

affiliated college;

(f) "Constituent College" means a college maintained and administered by the University;

"Dean" means the Chairman of the Board of a Faculty as shown in the Schedule;

"Institute" means a \_ constituent institute maintained and administered by the University;

"Director" means the head of a Teaching Division or an institute established as a constituent institute by the University;

"Educational Institution" means an\_ institution imparting instruction in a subject or subjects relating to a faculty;

"Employee" means a person borne on pay roll of the University but shall not include:—

(a) a person holding purely fixed tenure post.

(b) a person appointed by the University on contract basis.

(c) a person on deputation with the University.

"Faculty" means a Faculty of the University;

"Government" means the Government of Balochistan;



“Prescribed” means prescribed by Regulations or Rules;

“Principal” means the head of a College;

“Professional College” means a college providing

for instruction in courses of studies leading to a degree in Medicine, Engineering, Agriculture, Commerce, Education, Law, Fine Arts, Management Sciences or such other subjects as may be prescribed by Regulations to be professional subjects;

“Pro-Vice Chancellor’ means the Pro-Vice Chancellor of the University;]

“Registered Graduate” means;

(i) a graduate of the University whose name is enrolled in the register maintained for

this purpose as prescribed; or

(ii) a graduate of any other University who has obtained permanent residence within the territorial jurisdiction of the University and whose name is enrolled in the register maintained by the University for this purpose as prescribed;

“Research Officer” means a person engaged whole time by the University for research and equivalent in rank to a University Teacher;

“Senate” means the Senate of the University;

“Syndicate” means the Syndicate of the University;

“Teachers” means Professors, Associate Professors, Assistant Professors and Lecturers engaged whole-time by the University or the College for teaching courses of studies prescribed for Honours, Postgraduate, M.Phil, Ph.D and post Doctorate classes and such other person as may be declared to be Teachers by Regulations;

“Rules” and “Regulations” means respectively the Rules and Regulations made or deemed to have been made under this Act for the time being enforce;

“Teaching Department” means a\_ teaching department maintained and administered or

recognized by University;

“University” means the University of Balochistan as incorporated under this Act;

“University Teachers” means a \_whole-time Teacher appointed on salary payable from the University fund or recognized by the University as such; and

“Vice Chancellor” means the Vice Chancellor of the University.

## CHAPTER — II THE UNIVERSITY

Incorporation.

Powers of the  
University.

1

3. () The University of Balochistan shall be deemed to have been established at Quetta in accordance with the provisions of this Act, with all legal consequences regarding succession and acquirement of rights and liabilities.

(2) The University shall consist of:—

(i) The Authorities and officers as provided by this Act or as may be prescribed as such;

(ii) The members of the Senate, the Syndicate, the Academic Council and other Authorities of the University;

(iii) All University Teachers and

(iv) — Emeritus Professors.

(3) The University shall be fully Autonomous body corporate by the name of the University of Balochistan and shall have perpetual succession and common seal, and may sue and be sued by the said name.

(4) The University shall be competent to acquire and hold property, both movable and immovable, and to lease, sell or otherwise transfer any movable and immovable property which may have become vested in or been acquired by it.

(5) All properties, rights and interests of whatever kind, used, enjoyed, possessed owned or vested in, or held in trust by or for the University of Balochistan as constituted under University of Balochistan Ordinance, 1970! (I of 1970) the University of Balochistan Employees (other than Officer and Teachers), (Pay Revision) Rules, 1972 the University of Balochistan Non-Teaching Officers (Pay Revision) Rules, 1974, the University of Balochistan Teachers National Pay Scales (Pay Revision) Rules, 1975, and all liabilities legally subsisting against the said University shall stand transferred to the University as reconstituted under this Act.

4. The University shall have the powers:—

(a) to provide for instruction in such branches of learning as it may deem fit, and to make

and dissemination of knowledge in such manner  
as it may determine;

to prescribe courses of studies to be conducted  
by it and the colleges;

to hold examinations and to award and confer  
degrees, diplomas, certificates, and other  
academic distinctions to and on persons who  
have been admitted to and have passed its  
examinations under prescribed conditions;

to confer honorary degrees or other distinctions  
on approved persons in manner prescribed;

to provide for such instruction for persons not  
being student of the University as it may  
determine, and to grant certificates and diploma  
to such persons;

to confer degree on persons who have carried on  
independent research under prescribed  
conditions;

to affiliate and disaffiliate educational  
institutions under prescribed conditions;

to admit educational institutions to its privileges  
and to withdraw such privileges under prescribed  
conditions;

to inspect colleges and other educational institutions associated or seeking associations with it;

to accept the examinations passed and the periods of study spent by students of the University at other Universities and places of learning equivalent to such examinations and periods of study in the University as it may determine and to withdraw such acceptance;

to cooperate with other Universities and public authorities in such manner and for such purpose as it may determine;

to institute Professorships, Associate Professorships, Assistant Professorships and Lecturerships and any other posts and to appoint persons thereto;

to create posts for research, publications, extension administration and other related purpose and to appoint person thereto;

to recognize selected members of the teaching staff of affiliated colleges and colleges or educational institutions admitted to the privileges of the University or such other persons as it may deem fit as University Teachers;

To institute and award fellowships, scholarships, exhibitions, bursaries, medals and prizes under prescribed conditions;

to establish teaching departments schools, colleges, faculties, institutes, © museums, laboratories, workshops, hospitals, farms and others centers of excellence, and study centers for the development of teaching and research and to make such arrangements for \_ their maintenance, management and administrations as it may determine;

to supervise and control the discipline of the students of the University and the colleges, to promote the extra curricular and recreational activities of such students and to make arrangements for promoting their health and general welfare;

to demand and receive such fees and other charges as it may determine;



to enter into carry out, vary or cancel contracts;

to receive and manage property transferred and grants, bequests, trusts, gifts, donations, endowment and other contributions made to the University and to invest any fund representing such property, grants, bequests, trusts gifts, donations, endowment or contributions in such manner as it may deem fit;

to provide for the printing and publication of research and other works; and

to do all such other acts and things, whether incidental to the powers aforesaid or not, as may be requisite in order to further objects of

Jurisdiction of the University.

University as a place of education, learning and research.

5. () The University shall exercise the powers conferred on it by or under this Act, within the territorial limits of the Province of Balochistan and in respect of the Education Institutions lawfully functional within the Province of Balochistan imparting education of academic standards prescribed by the University:

Provided that Government may in consultation with the University, by general or special order, modify the extend and scope of the aforesaid powers of the University with regard to territorial limits of Educational institutions.

(2) No educational institutions situated within the territorial limits of the University shall, save with the consent of the University and the sanction of Government, be associated in any way with or seek admission to the privileges of any other University.

(3) The University may admit to its privileges under prescribed conditions, and educational institution falling within the territorial limits of another University, whether inside or outside Pakistan:

Provided that the prior consent of such other University and the sanction of Government is obtained.

6. The University shall be open to all persons of either sex and of whatever religion, race creed, class or colour and nationality and no person shall be denied the privileges of the University on the ground of religion race, creed, class, or colour:

Provided that nothing in this section shall be deemed to prevent religious instruction being given to the students in their own religious faiths in such manner as may be prescribed.

7. () All recognized teaching in various courses shall be conducted by the University or the colleges in the prescribed

manner and may include lectures, tutorials, discussions seminars, demonstrations as well as practical work in the laboratories, hospitals, workshop and farms and other methods of instructions.

(2) The authorities responsible for organizing recognized teaching shall be such as may be prescribed.

(3) The courses and the curricula shall be such as may be prescribed.

(4) A discipline to be called Islamic Education and Pakistan Studies shall be offered as a compulsory subjects at the Bachelor's Degree levels at all Arts, Science professional and other Faculties provided that non-Muslim students may opt for Ethics and Pakistan Studies.

(5) A degree shall not be awarded to a student unless he has passed the examination in the discipline referred to in sub-section (4).

University Students 8. () There shall be an Association of the students of Association. the University of Balochistan which shall be represented on the Senate by the Student Representatives of the University Association and the representative of the Associations of the Affiliated colleges to be elected by the Presidents of Student

Association of those colleges.

(2) The constitution, function and privileges of the University Students Association and the other matters relating thereto shall be such as may prescribed by Senate after initiation by the general body of the students of the University.

### CHAPTER — III OFFICERS OF THE UNIVERSITY

Officers of the 9. The following shall be the officers of the University.

(xi) — such other officers as may be prescribed by the Regulations.

10. () The Governor of Balochistan shall be the Chancellor of the University.

(2) The Chancellor or his nominee shall preside at the convocation of the University and the meetings of the Senate.

(3) If the Chancellor is satisfied that the proceedings of any Authority are not in accordance with the provisions of this Act, the Statutes, the Regulations, or the Rules, he may, after calling upon such Authority to show cause as to why such proceedings should not be annulled, by order in writing, annul the proceedings.

(4) Every proposal to confer an honorary degree shall be subject to confirmation by the Chancellor.

(5) The Chancellor shall have the power to assent to such Rules and Regulations as are required to be submitted to him by the Senate or with-hold assent or refer them back to the Senate for reconsideration.

(6) The Chancellor may remove any person from the membership of any Authority if such person:—

(i) has become of unsound mind; or

(ii) has been incapacitated to function as member of such Authority; or

(iii) has been convicted by a court of law of an offence involving moral turpitudes.

(iv) has failed to attend three consecutive meetings of the authority; or

(v) has accepted any assignment which involves his absence from the University for a continuous period of six months or more:

Provided that no order under this sub-section shall be passed unless the person to be affected thereby is afforded an opportunity of being heard.

(vi) \_ the Chancellor may, of his own motion or otherwise, call for to examine the record

of any proceedings in which an order has been passed by any Authority for the purpose of satisfying himself as to the correctness, legality or propriety of any finding or order and may pass such orders as he may deem fit:

Provided that no order under this sub-section shall be passed unless the person to be affected thereby is afforded an opportunity of being heard.

(7) The Chancellor shall have the power to appoint the Dean of each Faculty on the recommendations of the Vice Chancellor from amongst the Professors in the Faculty.

11. () The Chancellor may cause an inspection or inquiry to be made in respect of any matter connected with the affairs of the University, and shall, from time to time, appoint such person or persons as he may deem fit for the purposes of carrying out inspection or holding inquiry in respect of:—

(i) the University, its buildings, laboratories, libraries museums, workshops and equipment;

(ii) any institution, college or hostel maintained or recognized by, or affiliated to the University;

(iii) the teaching and other work conducted by the University; and

(iv) the conduct of examination held by the University.

(2) The Chancellor shall, in every such case as aforesaid, give notice to the Syndicate of his intention to cause an inspection or inquiry to be made under sub-section (1) and the Syndicate shall be entitled to be represented thereat.

(3) The Chancellor shall communicate to the Syndicate his views with regard to the result of such inspection or inquiry and shall after ascertaining the views thereon of the Syndicate advise the Syndicate on the action to be taken.

(4) The Syndicate shall communicate to the Chancellor such action, if any, as has been taken or may be proposed to be taken upon the results of the inspection or

inquiry. Such communication shall be submitted to the Chancellor within such time as may be specified by the Chancellor.

(5) Where the Syndicate does not, within a specified time take action to the satisfaction of the Chancellor, the Chancellor may, after considering any explanation furnished or representation made by the Syndicate issue such directions as he thinks fit, and the Vice Chancellor shall comply with such direction as if the same was decision of the concerned authority.

12. [\*\*] The Vice Chancellor shall be appointed by the Chancellor on such terms and conditions as the Chancellor may determine and shall hold office during the pleasure of the Chancellor for a term of four years or more which may be extended by the Chancellor from time to time.

13. () The Vice Chancellor shall be the principal executive and academic officers of the University and shall ensure that the provisions of this Act, the Statutes, the Regulations and the Rules are faithfully observed in order to promote teaching, research publication, administration, the general efficiency and good order of the University. He shall have all powers necessary for this purpose including administrative control over all officers, teachers, and other employees of the University.

(2) The Vice Chancellor shall, in the absence of the Chancellor, preside at the convocation of the University and the meetings of the Senate and shall if present, preside at the meetings of the Authorities of which he is the Chairman and be entitled to attend and preside at any meeting of any other Authority or body of the University.

(3) The Vice Chancellor may, in an emergency which in his opinion requires immediate action, take such action as he may consider necessary and shall as soon thereafter as possible, report his action to the officer, authority or other body which in the ordinary course, would have dealt with the matter.

(4) The Vice Chancellor shall also have the

to create and fill temporary posts for a period not exceeding six months;

to sanction all expenditure provided for in the approved budget, and to re-appropriate funds within the same major head or expenditure;

to sanction by re-appropriation an amount not exceeding five thousand rupees for an unforeseen item not provided for in the budget, and report it to the Syndicate at the next meeting;

to appoint paper setters and examiners for all examinations of the University after receiving panels of names from the relevant authorities;

to make such arrangements for the scrutiny of papers, marks and results as he may consider necessary;

to direct teachers, officers and other employees of the University to take up such assignments in connection with teaching, research, examination, administration and such other activities in the University as he may consider necessary for the purpose of the University;

to delegate, subjects to such conditions, if

any as may be prescribed any of his powers under this Act to an officer or officers of the University.

to exercise and perform such other powers and functions as may be prescribed; and

to appoint employees in Basic Pay Scale 1 to 16.

(2) At any time when the office of the Vice Chancellor is vacant or the Vice Chancellor proceeds on official tour or is absent or is unable to perform the functions of his office due to illness or other reason, the Pro-Vice Chancellor will perform the duties of the Vice Chancellor.

Powers and Duties 13-B. (1) The Pro-Vice Chancellor shall assist the Vice of the Pro-Vice Chancellor in all University affairs. All matters requiring Chancellor. orders, approval, sanction from the Vice Chancellor shall be

routed through the Pro-Vice Chancellor.

(2) The Pro-Vice Chancellor shall be ex-officio member on all the Statutory Bodies of the University, such as Senate, Syndicate, Academic Council, Finance and Planning Committee, Advance Studies and Research Board, Selection Board and the Affiliation Committee.]

Registrar. 14. The Registrar shall be a whole-time officer of the University and shall be appointed by the 'Syndicate on such terms and conditions as may be determined by it he shall:—

(a) be the custodian of the common seal and the academic records of the University;

(b) maintain a registrar of registered graduates in the prescribed manner;

(c) conduct elections of members to the various authorities in the prescribed manner; and

(d) perform such other duties as may be prescribed.

Treasurer. 15. The Treasurer shall be a whole-time officer of the University and shall be appointed by the Chancellor on such

terms and conditions as the Chancellor may determine he shall:—

(a) serve as custodian of the University Fund

The last Ordinance being made within 90 days before the Declaration of Emergency on 3<sup>rd</sup> November, 2007, was given permanence by the Provisional Constitution Order No. 1 of 2007 and validated by a decision of the Hon' able Supreme Court of Pakistan in C.P. No. 87 & 88 of 2007; later through another decision passed on 31 July, 2009 by the Honorable Supreme Court in C.P. No. 1 of 2009, it was decided that the same require approval of the Provincial Assembly within the period as prescribed in Article 123 of the Constitution of Pakistan, 1973, from the date of Judgment. A bill for the amendments was tabled in the Provincial Assembly of Balochistan which remained pending and was lapsed on the dissolution of the Assembly.

Property and assets;

(b) manage the property, the finances and the investment of the University;

(c) prepare the annual and revised budget estimates of the University and present them to the Finance and Planning Committee, the Syndicate and the Senate;

(d) ensure that the funds of the University are expended on the purposes for which they are provided; and

(e) perform such other duties as may be prescribed.

Controller of 16. The Controller of Examination shall be a whole time Examination officer of the University and shall be appointed by the 'Syndicate on such terms and conditions as may be determined by it. He shall be responsible for all matters connected with the

conduct of examinations and perform such other duties as may be prescribed.

Auditor. 17. () There shall be a Resident Auditor who shall be an officer in the service of Government whose services have been lent to the University.

(2) The duties of University Auditor shall include pre-audit of all bills and demands for payment submitted to the University.

#### CHAPTER - VI AFFILIATION OF EDUCATIONAL INSTITUTIONS TO THE UNIVERSITY

31. qd) An educational institution applying for affiliation to the University shall make an application to the University and shall satisfy it:—

(a) That the educational institution is under the management of the Government or of a regularly constituted governing body;

(b) That the financial resources of the educational institution are sufficient to enable it to make due provision for its continued maintenance and\_ efficient working;

(c) That the strength and qualifications of the teaching and other staff, and the terms and conditions of their services are adequate to make due provision for the courses of instruction, teaching or training to be undertaken by the educational institution;

(d) That the educational institution has framed proper rules regarding the efficiency and discipline of its staff and other employees;

(e) That the building in which the educational institution is to be located is suitable, and that provision will be made, in conformity with the Rules and the

Regulations for the residence of students, not residing with their parent or guardians, in the hostels, established and maintained by the educational institution or in hostels or lodging approved by it, and the supervision and general welfare of students;

(f) That provision has been made for a Library and adequate library services;

(g) That where affiliation is sought in any branch of experimental sciences, due arrangements have been made for imparting instruction in that branch of science in a properly equipped laboratory, museum and other places of practical work;

(h) That due provision will, so far as circumstances may permit, be made for the residence of principal and members of teaching staff in or near the college or the place provided for the residence of students; and

(i) That the affiliation of the educational institution, having regard to the provision which may have been made for the students by another — educational institution in its neighborhood, will not be injurious to the interest of education or discipline.

(2) The application shall further contain an undertaking that after the educational institution is affiliated any transference of and changes in the management and in the teaching staff, same in the case of Government Colleges, shall be forthwith reported to the University, and that the teaching staff shall possess such qualifications as are, or may be prescribed.

(3) The procedure to be followed in disposing of an application for the affiliation of an educational institution shall be such as may be prescribed.

(4) The Syndicate may, on the recommendation of the Affiliation Committee, grant or refuse affiliation to an educational institution;

Provided that affiliation shall not be refused, unless the educational institution has been given an opportunity of making a representation against the proposed decision.

## CHAPTER — VII

36. The University shall have a fund to which shall be credited its income from fees, donation, trusts, bequests, endowments, contributions, grants and all other sources.

37. All sums and amount lawfully recoverable the University shall be treated as revenue arrears. The University or any person generally or specially authorized by it may send a requisition to the collector for the recovery of any sum due to

38. () The Accounts of the University shall be maintained in such form and in such manner as may be prescribed.

(2) No expenditure shall be made from the funds of the University unless;

(a) The expenditure is included in the approved budget of the University; and

(b) A bill for its payment has been audited by the Resident Auditor in conformity with the Rules and Regulations.

(3) The annual statement of the accounts of the University signed by the Treasurer and the Resident Auditor, shall be submitted to Government within six months of the financial year.

(4) The accounts of the University shall be audited once a year in conformity with the Rules and Regulations by the Auditor appointed by the Government for this purpose.

(5) The observations of Government Auditor, together with such annotations as the Treasurer may make, shall be presented to the Syndicate.

## CHAPTER — VII GENERAL PROVISIONS

39, () All employees of the University including employees appointed on contract basis and or on fixed tenure posts shall be deemed to be provincial public servants as defined by Section 21 of Pakistan Penal Code:

Provided that the sanction of their prosecution shall be granted by the respective complete authority in the University and not be any other authority prescribed by Federal

or Provincial Government.

(2) An Officer, Teacher or other employee of the University shall retire from service:

(i) On such date after he has completed 25 years of service qualifying for pension or



other retirement benefits as the competent authority may, in the public interest direct, or

(ii) Where no direction is given under clause (1) on the completion of the sixty years of his age.

Explanation:- In this section "Competent Authority or a person duly authorized by the appointing authority in that behalf, not being a person lower in rank to the officer, teacher or other concerned

employee".

43. qd) Notwithstanding anything to the contrary contained in any agreement or contract or in any other law for the time being enforce, but subject to the provision of the Act, an officer, teacher or other employee shall, if the Chancellor so directs in the public interest, serve for such period as may be fixed or extended from time to time by the Chancellor in any part in Government Department or an Educational or research institution set up, or established by the Government or by a University in the Province of Balochistan and no terms and conditions not less favourable than those admissible to him in the University and with full benefits of his previous services:

Provided that in the case of a teacher such a direction shall not be made without consulting the Syndicate.

(2) The Chancellor may fill any post in the University by appointing a person in the service of the Government or an officer, teacher or other employee of any other University or Education or Research Institution set up or established by the Government or by the University in the Province of Balochistan:

Provided that in the case of teaching post in the University, the appointment shall not be made without consulting the Selection Board of the University.

The members mentioned in sub-clause (iii) and (iv) above shall hold office for three years.

The quorum for a meeting of the Board of a Faculty, shall be one-half of the total number of members, fraction being counted as one.

The Board of each Faculty shall, subject to general control of the Academic Council and the Syndicate, have the powers—

(a) To re-ordinate the teaching, research and publication work in the subject assigned to the Faculty.

(b) To scrutinize the recommendations of the Board of studies, comprised in the Faculty in regard to the appointment of paper setters and examiners, except for research examinations, and to forward the panels of suitable paper setters and examiners for each examination to the Vice Chancellor.

(c) To consider any other academic matter relating to the Faculty and to report thereon to the Academic Council; and

(d) To perform such other functions as may be prescribed by Statutes.

Dean. 2. qd) There shall be a Dean of each Faculty who shall be the Chairman and convener of the Board of Faculty.

(2) The Dean of each Faculty shall be appointed by the Chancellor from amongst the three most senior Professors in the Faculty.

(3) The Dean shall hold office for three years.

(4) The Dean shall present candidates for admission to degree except honorary degrees, in the courses falling within the purview of the Faculty.

(5) The Dean shall exercise such other powers and perform such other duties as may be prescribed.

Teaching 3. qd) There shall be a Teaching Department for each Department — subject or a group or subjects, as may be prescribed by and Regulations, and each Teaching Department shall be headed by Chairman.

(2) The Chairman of Teaching Department, or the Director of an Institution shall be appointed by the Syndicate on the recommendation of Vice Chancellor, from amongst three senior most Teachers in the Department by rotation for a period of three years and shall be eligible for re-appointment;

Provided that in a Department where there are less than three Professors the appointment shall be made from amongst the three senior most Professors and Associate Professors of the Department:

Provided further that in a Department in which there is no Professor or Associate Professor as such appointment shall be made and the Department shall be looked after by the Dean of the Faculty with the assistance of the senior most Assistant Professor or Lecturer of the Department.

(3) The Chairman of the Department shall plan, organize and supervise the work of the Department and shall be responsible to the Dean for the work of his Department.

4. qd) There shall be a separate Board of Studies for each subject or group of subjects, as may be prescribed by Regulations.

(2) Each Board of Studies shall consist of:

(i) The Chairman of the Teaching Department;

(ii) All Professors and Associate Professors in the University Teaching Department;

(iii) Three teachers of the subject including Heads of Departments of the Affiliated Colleges where post graduate teaching in the subject is being done, to be appointed by the Vice Chancellor.

Provided that if the total number of University Teachers under sub-clause (i) and (ii) comes to less than three, then this number may be made up by nominating other University Teachers as in sub-clause (iii).

(iv) Two University Teachers, as the case may be other than a Professor or an Associate Professor, to be appointed by



the Academic Council;

(v) Three Teachers other than University Teachers to be appointed by the Syndicate. The number will be determined by the Syndicate according to the need of each Board; and

(vi) One expert to be appointed by the Vice Chancellor.

Provided that in the case of subjects which are taught in the Teaching Department or constituent colleges only, such as Law, Journalism etc; the Board of Studies shall consist of:

(a) The Chairman of the University Teaching Department appointed by the Syndicate;

(b) All Professors and Associate Professors in the University Teaching Department;

(c) One University Teacher, other than a Professor or an Associate Professor, to be appointed by the Academic Council; and

(d) Four experts to be appointed by the Vice Chancellor from outside the Jurisdiction of the University.

Provided further that in the case of professional subject which are taught in the affiliated colleges only, and not in the University such as Medicine, Animal Husbandry, Dentistry, Home Economics, Engineering, Agriculture etc, the Board of Studies shall consist of:

(a) The Principals of the colleges concerned;

(b) Five teachers of the colleges, to be appointed by the Syndicate; and

(c) Two experts to be appointed by the Vice Chancellor from outside the jurisdiction of the University.

Provided also that in the case of such subjects of Humanities and Sciences as are taught in the affiliated colleges only and not in the University, the Board of Studies shall consist of:

(a) Four teachers from the colleges doing

7. () The Selection Board shall consider the applications received in response to advertisement and recommend to the Syndicate the names of suitable candidates for appointment to teaching and other posts.

(2) The Selection Board may recommend to the Syndicate grant of a higher initial pay in a suitable case of reasons to be recorded.

(3) The Selection Board may recommend to the Syndicate the appointment of eminently qualified person to a

(b) To inquire into complaints alleging breach of conditions of affiliation by affiliated colleges and to advise the Academic Council thereon; and

(c) To perform such other functions as may be prescribed by Regulations.

11. () The Discipline Committee shall consist of:—

(i) One of Deans as Chairman nominated by Syndicate;

(ii) Two Professors to be nominated by the Academic Council;

(iii) One member to be nominated by the Syndicate;

(iv) The Teacher or Officer incharge of

Students Affairs by whatever name called (Member Secretary); and

(v) Two nominees of the Academic Staff Association.

(2) The terms of office of the members of the Discipline Committee, excluding ex-officio members, shall be,

two years.

(3) The quorum for a meeting of the Discipline Committee shall be four members.



(4) The functions of the Discipline Committee shall be:-

(i) To propose Regulations to the Academic Council for the conduct of University students, maintenance of discipline and for dealing with cases of undiscipline; and
