Preamble, WHEREAS it is expedient to amend the West Pakistan Entertainments, Duty Act, 1958 (Act X of 1958) in its application to the province of Baluchistan in the manner hereinafter appearing;

AND WHEREAS the Governor of Baluchistan is satisfied that circumstances exist which render it necessary for him to take immediate action;

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977, read with the Laws (Continuance in Force) Order, 1977 (CMLA ORDER No. 1 of 1977) and in exercise of all powers enabling him in taht behalf the Governor. of Baluchistan 'is pleased to make and promulgate' the following Ordinance; namely:—

Short title, 1. (1) This Ordinance: may be called the extent and West Pakistan Entertainments Duty (Baluchistan commence- Amendment) Ordinance, 1978. ment.

Penalty for non-compliance with Sections 4 and 5-if any person is admitted to any place of entertainment and the provisions of Section 4or5, asthe case may be, are not complied with, or the payment of entertainments duty is otherwise evaded, the Collector shall, in addition to the recovery of the entertainments duty evaded or under paid, impose on the proprietor of the entertainment to which such person is admitted, a penalty not exceeding a _ Sum of five hundred rupess, orasum not greater than five times the entertainments duty the payment of which was evaded, whichever is greater:

. Provided that no such penalty shall be imposed unless the person on whom it is to be imposed or his duly authorised agent is given an opportunity of being heard by the Collector, orby an officer authorised by him in this behalf, "
