"WHEREAS it is expedient to :fu:ther amend the West Pakistan Entertainments Duty Act, 1958 (Act X of 1958) inits application to the province of Baluchistan in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of proclamation of the fifth day of July 1977, read with the Laws (continuance in force) Order 1977 (CMLA QRDER No. | of 1977) and in exercise of all . powers enabling him in that.behaif, the Governor of Baluchistan is pleased to make and promulgate the following Ordinance, namely:— }

(1) This Ordinance may be called the West skis Entertainments Duty (Baluchistan Amendment) Ordinance, 1 978.

+ (2) It shall come into force at once and shall, be deemed to have taken effect from 1st July, 1969.

(3) It shal}. extend ot whole province of Baluchistan except Tribal Areas.
