Preamble, ' WHEREAS it is expedient to. amend the West Pakistan Finance Ordinance, 1969 (West Pakistan Ordinance No. VII of 1969) in its application to the Province of Baluchistan in the manner hereinafter appearing;

AND WHEREAS the Governor of Baluchistan issatisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977, read with the Laws (Continuance in Force) Order, 1977 (CMLA ORDER NO.I of 1977), and in exercise of all powers enabling him in that behalf, the -Governor of Baluchistan is pleased to make and promulgate the following Ordinance, namely : -

Short title extent 1. (1) This Ordinance: may be called the West Pakistan and commence- Finance (Baluchistan Amendment) Ordinance, 1978, :

(2) It shall come into force at once and shall be fennies to have taken effect from 3rd September, 1973.

(3) Itshall extend to whole province of Baluchistan except tribal areas.

Amendment 2. In the West Pakistan Finance Ordinance, 1969 (West of clause (i)of Pakistan No. VU of 1969) in clause (i) of Sub-section (1) Section 8, (i) of of Section 8, for the amount "Ten Paisa" the amount West Pakistan "Twenty Paisa" shall be substituted. :
