~ Preamble. WHEREAS it is expedient to amend the sixth Schedule appended to the West Pakistan Motor Vehicles Ordinance-1965 (Ordinance XIX of 1965) in its application to the Province of Baluchistan. z

AND' WHEREAS the Governor is satisfied that circumstances exist which render it necessary to take immediate action:

NOW. THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977, read with the Laws (Continuance in Force) Order, 1977, (CMLA ORDER' NO. 1 OF 1977), and in exercise of all powers enabling him in that behalf, the Governor of Baluchistan is pleased to make and promulgate the following Ordinance:-

Short title, | 1, (i, This Ordinance may be called the West Pakistan Motor Vehicles (Baluchistan) Amendment Ordinance, 1978." :

- " (ii) It extends to the whole of the Province of Baluchistan.

(iii) It shall come into force at once and shall

be deemed to have taken effect from
