to amend the University of Balochistan Act, 1996  
(IIL of 1996),

Preamble. WHEREAS it is expedient to amend the University of Balochistan Act, 1996, in the manner hereinafter appearing:

AND WHEREAS the Provincial Assembly of Balochistan stands suspended in pursuance of proclamation of Emergency of the fourteenth day of October, 1999, and the Governor of Balochistan is satisfied that circumstances exist which render it necessary to take immediate action:

NOW. THEREFORE, in pursuance of Article 4 of the Provisional Constitution (Amendment) Order. 1999 (Chict Executive's Order No. 9 of 1999), and in exercise of all powers enabling him in that behalf. the Governor of Balochistan is pleased to make and promulgate the following Ordinance:-
