THE LAC CESS ACT, 1930
ACT No. XXIV OF 1930
[25th July, 1930]

'TAn Act to provide for the levy and collection of a cess on lac and refuse lac exported from Pakistan.]

'TWhereas it is expedient to provide for the levy and collection of a cess on lac and refuse lac exported from Pakistan;]

It is hereby enacted as follows:—

1. Short title, extent and commencement.—(1) This Act may be called the 7[*] Lac Cess Act, 1930.

3[(2) It extends to the whole of Pakistan.]

(3) It shall come into force on such date as the “[Federal Government] may, by notification in the *[official Gazette,] appoint.

2. Definitions. In this Act—

(c) “Jac” includes any form of manufactured or unmanufactured lac other than refuse lac;

(d) “lac cess” means the customs duty imposed by section 3.

3. Imposition of lac cess. There shall be levied and collected on all lac and refuse lac *[exported from Pakistan] °[* * *] a cess at the rate of “[seven annas] per maund in the case of lac, and °[five annas] per maund in the case of refuse lac, or at such 7[other] rate as the “[Federal Government] may, °[* * *], by notification in the *[official Gazette], prescribe.
