In the said Act, in place of sub-section 16(1) and  
-16(2), the following new sub-section 16(1) shall  
be added:

following sub-section (2) shall be added:

“16(3) The Deputy Speaker shall be entitled to  
receive medical allowance at the rate of  
“twenty eight thousand rupees” per month.”

phone shall be scraped out.

In the said Act, the following sub-section 21(a)

hall be added:

O1(a) the Deputy Speaker shall be entitled to

receive Mobile expense at the rate of “fifteen thousand rupees” per month”,
