An Act to amend the Gilgit Baltistan Legislative Assembly Parliamentary Secretaries (Salaries, Allowances and Privileges) Act, 2011.

Whereas it is expedient to 'amend the Gilgit Baltistan Legislative Assembly Parliamentary Secretaries (Salaries, Allowances and Privileges) Act, 2011, in the manner — hereinafter appearing:

Preamble

It is hereby enacted as follows:—°

1. This Act may be called the Gilgit Baltistan Short title and Legislative Assembly Parliamentary' Secretaries commencement (Salaries, Allowances . .and Privileges) ; (Amendment) Act, 2015.

It shall come into force at once."
