Whereas, it is expedient to amend the Azad Jammu and

Kashmir Anti-Corruption Establishment Act, 1993 (Act XII of 1994);

It is hereby enacted as follows:-

Short title and commencement.- (1) This Act may be

called the Azad Jammu and Kashmir Anti-Corruption Establishment (Amendment) Act, 2024.

(2) It shall extend to whole of Azad Jammu and Kashmir.

(3) It shall come into force at once.

Substitution of Schedule, Act XII of 1994.- In the

Azad Jammu and Kashmir Anti-Corruption Establishment Act, 1993 (Act XII of 1994), the Schedule shall be

substituted as follows:-

“SCHEDULE

See Section 3 (1)

(a) Offences punishable under Section 109, 161 to 169, 186, 188, 189, 196 to 198, 201, 215, 217 to 219, 221 to 223, 353, 379, 381, 403 to 409, 411, 417 to 420, 465 to 474, 477 and 477-A of Azad Penal Code, 1860 (Act XLV of 1860), as in

force in Azad Jammu and Kashmir;

(b) Attempts, abetments and _ conspiracies’ in relation to or connected with the offences specified under the preceding clause (a) when committed by any public servant as such, or by any person acting jointly with or abetting or attempting to abct or acting in conspiracy with

any public servant as such;

(c) Offences punishable under the Azad Kashmir

Prevention of Corruption Act, 1950; and

(d) Offences punishable under the — Official
Misdemeanor Act of 1948 and attempts,
abetments and conspiracies in relation thereto

or connected therewith.”

Repeal.- The Azad Jammu and Kashmir Anti-
Corruption Establishment (Amendment) Ordinance,

2024 (Ordinance IV of 2024) is hereby repealed.
