No, 3936/ SL/ 75 The following Act, of the Legislative  
Assembly received the assent of the President on the 16th day of  
December, 1975, and is hereby published for general information:-

(ACT XXI OF 1975)

An Act to provided for re-adopting and regulating the use of  
State flag.

WHEREAS it is expedient to provided for re-adopting and  
regulating the use of the Stat flag, in the manner hereinafter appearing;

It is hereby enacted as follows:-

1. Short title and commencement:- (1) This Act may be called the  
Azad Jammu and Kashmir State Flag Act, 1975.

(2) It extends to the whole of Azad Jammu and Kashmir  
territory and shall apply to all the state subject of Jammu and  
Kashmir wherever they may be.

(3) It shall come into force with effect from the commencing  
day.

2. Definition: In the Act, unless there is anything repugnant in the  
subject or context:-

(a) "Government" means the Azad Government of the State  
of Jammu and Kashmir;

(b) "State Flag" means the flag which was in use as the flag  
of Azad Jammu and Kashmir in the period commencing  
immediately after the setting up to the Azad Government  
of the State of Jammu and Kashmir in the year 1947 and  
ending with the twenty third day of August, 1947 as  
specified in schedule of this Act;

(c) "Commencing day" means the day fixed by the  
Government by Notification in the Government Gazette  
for coming into force of this Act;

(d) "Person" includes any body politic or corporate;

(e) "Prescribed" means as prescribed by rules made under section 7 of this Act;

Re-adopting of state flag: (1) The Stat flag shall be re-adopted as the flag of Azad Jammu and Kashmir with effect from the commencing day and shall continue to be used as such till the accession of the State of Jammu and Kashmir to Pakistan.

(2) The State flag shall be given due respect by the Government and the State subject wherever they may as the symbol, of freedom movement of the people of Jammu and Kashmir.

Use of state flag: (1) The manner in which the State flag will be used and the persons entitled to the use of the State flag shall be such as may be prescribed.

(2) The State flag shall not be hosted or used except as provided in sub-section (1) of this section.

Ban of use of the discarded flag: (1) The flag being used as the flag of Azad Jammu and Kashmir immediately before the commencing day, shall stand discarded from the commencing day and all such flag shall be deposited with the Govt, which will arrange for their preservation.

(2) No person shall use the flag so discarded or any flag of that design for any purposes whatsoever.

Forfeiture and Punishment: (1) ny person who contravenes the provisions of this Act or abets such contravention shall be punished with simple imprisonment which may extend to three months or with fine not exceeding two thousand rupees or with both and any flag being used in contravention of there provision may be seized by a police officer not below the rank of a sub-inspector and shall be forfeited to the State.

(2) The offences under this Act shall be cognizable and non-bail able and shall be triable by magistrate of the First class.

Rules: The Government may make rule for carrying out the purposes of this Act.

Repeal: The Azad Jammu and Kashmir state Flag Ordinance 1975 (Ordinance XXXI of 1975) is hereby repealed.
