ACT

to amend the Azad Jammu and Kashmir Cease Fire Line Incidents Relief Act, 1992

WHEREAS it is expedient to amend the Azad Jammu and Kashmir Cease Fire Line Incidents Relief, Act (Act XXIV of 1992), for the purposes hereinafter appearing;

It is hereby enacted as follows: -

1. Short title, extent\_and\_commencement:- This Act may be called the Azad Jammu and Kashmir Cease Fire Line Incidents Relief (Amendment) Act, 2002.

(2) It shall come into force at once.

2. Substitution of Schedule, Act XXIV of 1992:- In Azad Jammu and Kashmir Cease Fire Line Incidents Relief Act, 1992, for the Schedule at the end, the following new schedule shall be substituted and item No. 1 and 2 whereof shall be deemed to have been so substituted since, 1st January, 1999.

Schedule

1. Death: (1) Rupees fifty thousand.

2. Injury: (i) Rupees twenty five thousand in case of permanent disability;  
(ii) Rupees five to fifteen thousand in case of other injury

3. Immovable property (House, Shop and vehicle).
