further to amend the Azad Jammu and Kashmir Cease Fire Line Incidents Relief Act, 1992

WHEREAS it is expedient further to amend the Azad Jammu and Kashmir Cease Fire Line Incidents Relief Act, 1992 (Act XXIV of 1992) for the purposes here-in-after appearing;

It is hereby enacted as follows:-

1. Short title and Commencement.- (1) This Act may be called the Azad Jammu and Kashmir Cease Fire Line Incidents Relief (Amendment) Act, 2014.

(3) It shall come into force at once and shall be deemed to have taken effect from 13.05.2014.

2. Substitution of Schedule, Act XXIV_of_1992.-In the Azad Jammu and Kashmir Cease Fire Line Incidents Relief Act, 1992 (Act XXIV of 1992), for the existing Schedule at the end, following schedule shall be substituted: -

Compensation payable in certain cases and amount of compensation for relief

1. Death: Rs. 300,000/-

Injury:

- (i) Rs. 2,50,000/- in case of permanent disability.
- (ii) Rs. 1, 00,000/- in case of grievous injury.
