ACT

to amend further the Azad Jammu & Kashmir Distressed Persons relief Act, 1985.

Whereas, it is expedient to amend the Azad Jammu and Kashmir Distressed Persons relief Act (Act XXIX of 1985), and to enhance the amount of compensation payable to distressed persons:

It is hereby enacted as follows:-

1. Short title and Commencement.- (1) The Act may be called the Azad Jammu & Kashmir Distressed Persons Relief (Amendment) Act, 2006.

(2) It shall extend to the whole of Azad Jammu & Kashmir.  
(3) It shall come into force at once.

2. Substitution of the Schedule, (Act XXIX of 1985).- In the Azad Jammu & Kashmir Distressed Persons Relief Act, (Act XXIX of 1985), the existing schedule at the end shall be substituted as under:-

“SCHEDULE

Amount of compensation payable in case of

1. Death (i) Rs. 50,000/- per person  
2. Injury (i) Rs. 25,000/- per person

(ii) Rs. 5,000/- to 15,000/- in case of grievous injury.

3. Immovable Property (house, shop, vehicle and cattle etc.

S.No | Description Nature of Loss Amount of Compensation

1. Pakka house Completely 25,000/- damaged

2. Pakka house Partially 15,000/- damaged

3. Kacha house Completely 15,000/- damaged

4. Kacha house Partially 10,000/- damaged

5. Pakka shop Completely 5,000/- damaged

6. Kacha shop Completely 3,000/- damaged

7. Heavy vehicle Completely 25,000/-

(bus, truck) damaged (Subject to the condition that the vehicle lost was the only source of livelihood for the affected person)

8. Light vehicle Completely 15,000/-

(coaster, wagon, | damaged (Subject to the jeep) condition that the vehicle lost was the only source of livelihood for the affected person)

9. Cattle loss

(i) Cow, Rs. 2,000/- to Rs. 4,000/-  
buffalo,  
horse,  
donkey,

(ii) Sheep goat.

Rs. 1,000/-

(Subject to the condition that the cattle lost was the only source of livelihood for the affected person)
