further to amend the Azad Jammu and Kashmir Distressed Persons Relief Act, 1985.

WHEREAS, it is expedient to amend the Azad Jammu and Kashmir Distressed Persons Relief Act, 1985 (Act, XXIX of 1985) for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1. Short title, Extent and Commencement.-(1) This Act may be called the Azad Jammu and Kashmir Distressed Persons Relief (Amendment) Act, 2011.

(2) It shall extend to the whole of Azad Jammu and Kashmir.

(3) It shall come into force at once and shall be deemed to have taken effect from 08.08.2011.

2. Substitution of the Schedule, Act XXIX\_ 1985.-In the Azad Jammu and Kashmir Distressed Persons Relief Act, 1985 (Act XXIX of 1985), the existing Schedule shall be substituted as under:-

“Schedule

Amount of compensation payable in case of,-

1. Death Rs. 150,000/- per person;

2. Injury (i) Rs. 75000/- per person in case of permanent disability,  
(ii) Rs. 50,000/- per person in case of grievous injury;

3. Immovable Property (House, Shop, Vehicle and Cattle etc.)
