NO. 722-729/LD/Leg/93. The following Act of the Assembly received the assent of the President on 16th June, 1993 is hereby published for general information:-

(ACT XXIII of 1993)

AN

ACT

to give effect to the financial proposal of Azad Government of the State of Jammu and Kashmir.

WHEREAS it is expedient to make provisions to give effect to the financial proposals of Azad Government of the State of Jammu and Kashmir and to amend certain Laws for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1. Short title and Commencement.-(1) This Act may be called the Azad Jammu and Kashmir Finance (Amendment) Act, 1993.

(2) It shall come into force at once and shall be deemed to have taken effect from 19th day of February, 1993.

2. Amendment of Section 3, Act XL of 1986.- In the Azad Jammu and Kashmir Finance Act, 1986 (Act XL of 1986) in Section 3,-

(a) In sub-section (1) clause (a) shall be omitted;

(b) for\clauses (b) the following shall be substituted namely:-

“(b) Admission fee for Indoor Rs. One  
Patients

(c) Laboratory Test Fee.

(i) Urine Test: Rs. One and Paisa  
fifty.

(ii) Blood C.P. Rs. Seven and Paisa  
fifty.

(iii) Special Investigation. Rs. Fifteen

(d) (i) X-Ray Charges Rs. Fifteen.  
per X-Ray),,

(ii) Special Investigation Rs. Fifteen.

(X-Ray)

(e) E.C.G. Rs. Twelve and Paisa  
fifty.

(f) Ultra Sound. Rs. Twelve and Paisa  
fifty

(g) Bed Fee. Paisa fifty per day.

(h) Operation Fee

(i) Major Operation Rs. Fifty

(ii) Minor Operation Rs. Twenty Five

(iii) Operation room charges Rs. Twelve and Paisa  
fifty

(i) Medical or surgical Specialist Rs, One, and paisa  
fifty.

The poor will be exempted from the above fee and the fee on this  
account will be paid by the Institute concerned from the Fund  
placed at their disposal."

(c) Sub-section (2) shall be omitted.

Repeal.- The Azad Jammu, and Kashmir Finance (Amendment)  
Ordinance, 1993 (Ordinance XVI of 1993) is hereby repealed.
