ACT

to amend further the Azad Jammu & Kashmir Information Technology Board Act, 2001

WHEREAS it is expedient to amend the Azad Jammu & Kashmir information technology Board Act, 2001 (Act XXVI of 2001) in the manner hereinafter appearing

1. Short Title & Commencement. - (1) This Act may be called the Azad Jammu & Kashmir Information Technology Board (Amendment) Act, 2004.

(2) it shall come into force at once.

2. Amendment of Section 2, Act XXVI_ of 2001.- In the Azad Jammu & Kashmir Information Technology Board Act, 2001 (Act XXVI of 2001) hereinafter referred to as the said Act, in Section 2, after clause (g), the following new clause shall be added, namely;

"h) Member means Member of the Board."

3. Amendment of Section 4, Act XXVI of 2001.- In the said Act, subsection (1) of Section 4 shall be substituted as under:-
qd) The Board shall consist of the following members, namely:-

- (i) The President Chairman
- (ii) The Chief Secretary Vice Chairman
- (iii) The Additional Chief Secretary Member (Development)
- (iv) | The Secretary to the President Member
- (v) The Secretary Finance Member
- (vi) The Secretary Information Member Technology

(vii) | The Director General Member/
Secretary
(viii) | The Secretary Education Member
(ix) | The Secretary Industries Member
(x) The President Azad Jammu & Member
Kashmir Chamber of Commerce &
Industries

(xi) | One IT Professional Proposed by the | Member

DG IT Board

(xii) | Four Directors (nominated) by the Member
Govt.

(xiii) | One IT Professional, nominated by Member

the Vice Chancellor Azad Jammu &
Kashmir University.

Amendment of Section 5, Act XXVI of 2001.- in the said Act,
in Section 5, after clause (g) the following new clause shall be
added, namely:-

“(h) to ensure financial sanction of the Technical Board Fund
per approved policy plan for smooth operation of the
Board.”

Repeal.-The Azad Jammu and Kashmir Information Technology
Board (Amendment) Ordinance, 2004 (Ordinance IV of 2004) is
hereby repealed.
