ACT

to amend the Azad Jammu and Kashmir Legislative Assembly  
(Salaries, Allowances and Privileges of Members) Act, 1975

WHEREAS it is expedient to amend the Azad Jammu and  
Kashmir Legislative Assembly (Salaries, Allowances and Privileges of  
Members) Act, 1975 (Act XX of 1975) in the manner hereinafter

appearing;

It is hereby enacted as follows:-

1. Short title and Commencement.-\_ (1) This, Act may be called

the Azad Jammu and Kashmir Legislative' Assembly (Salaries,  
Allowances and Privileges of Members) (Amendment) Act,  
1990.

(2) It shall come into force at once and shall be deemed to have  
taken effect on and from the first day of July, 1989.

2. Amendment of Section 3, Act XX of 1975.- In the Azad Jammu  
and Kashmir Legislative. Assembly (Salaries, Allowances and  
Privileges of Members) Act, 1975 (Act XX of 1975), hereinafter  
referred to as the said Act, in Section 3, in sub-section (1) for the  
words "two thousand", the words "two thousand and five  
hundred" shall be substituted.

3. Amendment of Section 5-A, Act XX of 1975.- In the said Act,  
in Section 5-A, for the words "fifteen thousand" wherever  
occurring, the words "twenty five thousand" shall be substituted.

4. Amendment of Section 10, Act XX of 1975.- In the said Act,  
in Section 10, for the words "five hundred" the words "two  
thousand" shall be substituted.

5. Amendment of Section 10-A, Act XX of 1975.- In the said  
Act, in Section 10-A, for the words "five hundred" the words  
"two thousand and five hundred" shall be substituted.

6. Amendment of Section 11, Act XX of 1975.- In the said Act,  
in Section 11,-

- i) in clause (a) for the words “two” the word “three” shall be substituted;
- ii) in clause (e) in the second proviso, for the figure “5000/-” the words “six thousand” shall be substituted.

the following new sub-clause (f) shall be added :

“(f) use of not more than one Staff Car regardless of his entitlement to an Official Car in any other capacity and where he avails himself of this facility, he would not be entitled to the conveyance allowance under Section 4.”

Addition of Section 11-A, Act XX of 1975.- In the said Act, after Section 11, the following new Section 11-A , shall be

added:-

“11-A Official Transport.- A Member who holds the Office of

Chairman of a Committee of Assembly, other than that of a Select Committee or a Special Committee, shall be entitled to the use of not more than one official car regardless of his entitlement to have an official car in any other capacity, and where he avails himself of this facility, he shall not be entitled to-receive the conveyance allowance under Section 4, and Travelling Allowance under Section 5:

only one Car shall be provided\to, a Chairman of a

Standing Committee during the whole term of his office; a Chairman of a Standing Committee shall be allowed rupees three thousand per month as petrol and maintenance allowance. and expenses on petrol and maintenance of -the Car shall entirely be his responsibility;

on ceasing ‘to hold office the Chairman of the Standing Committee shall return the Car within three days.”
