ACT

to amend the Azad Jammu and Kashmir Legislative Assembly Deputy Speaker, (Salary, Allowances and Privileges) Act, 1986

WHEREAS it is expedient to amend the Azad Jammu and Kashmir Legislative Assembly Deputy Speaker (Salary, Allowances and Privileges) Act, 1986 for the purposes hereinafter appearing;

It is hereby enacted as follows: -

1. Short title and commencement. - (1) This Act may be called the Azad Jammu and Kashmir Legislative Assembly Deputy Speaker(Salary, Allowances and Privileges) (Amendment) Act, 2003.

(2) It shall come into force at once and shall be deemed to have taken effect from 1st January, 2003.

2. Amendment of Section 3, Act VIII of 1986. — In the Azad Jammu and Kashmir Legislative Assembly Deputy Speaker (Salary, Allowances and Privileges) Act, 1986 (Act VI11 of 1986), hereinafter referred to as the said Act, in Section 3, for the words "twenty eight thousand", the words "thirty five thousand" shall be substituted.

3. Amendment of Section 7, Act VIII of 1986. - In the said Act, in section 7, for the words "fifteen thousand" wherever occurring, the words "twenty thousand" shall be substituted.

4. Amendment of Section 10, Act VIII of 1986. - In the said Act, in section 10, for the words "at such rate as may be determined by the finance committee", the words "five hundred and fifty" shall be substituted.

5. Amendment of Section 13, Act VIII of 1986.- In the said Act, in Section 13, in subsection (2), for the words "eighteen thousand", the words "thirty five thousand" shall be substituted.

Amendment of Section 16, Act VIII of 1986.- In the said Act, in Section 16, existing proviso shall be substituted as under : -

"Provided that the liability of Government in respect of the two telephones installed at the residence shall not exceed the amount equal to ten thousand local calls collectively for both the telephones."

Repeal. The Azad Jammu and Kashmir Legislative Assembly Deputy Speaker, (Salary, Allowances and _ Privileges) (Amendment) Ordinance, (Ordinance No. XX of 2002) is hereby repealed.
