No. 361-65/LD/Leg (A)/86. The following Act of the Assembly received the assent of the President on 5th day of March 1986 is hereby published for general information.

(ACT IX OF 1986)

ACT

to amend the Azad Jammu and Kashmir Legislative Assembly Speaker (Salaries, Allowances and Privileges) Act, 1975.

WHEREAS it is expedient to amend the Azad Jammu and Kashmir Legislative Assembly Speaker (Salaries, Allowance and Privileges) Act, 1975 (Act XVII of 1975):

It is hereby enacted as follows: -

1. Short title and Commencement.- (1) This Act may be called Azad Jammu and Kashmir Legislative Assembly Speaker (Salary, Allowances and Privileges) (Amendment) Act, 1986.

(2) It shall come into force at once and shall be deemed to have taken effect on and from the 15th day of June, 1985.

2. Amendment of Section 3, Act XVII of 1975.- In the Azad Jammu and Kashmir Legislative Assembly Speaker (Salary, Allowances and Privileges) Act, 1975, (Act XVII of 1975) hereinafter referred to as the said Act, in Section 3, for the words "Two thousand and five hundred" the words "five thousand" shall be substituted.

3. Amendment of Section 4, Act XVII of 1975. In the said Act, for Section 4 the following shall be substituted, namely:-

"4, Equipment Allowance.- The Speaker may draw a sum of three thousand rupees as equipment allowance on his appointment as such:

Provided that no such allowance was received by him during the life time of the Assembly as Speaker, Prime Minister or a Minister."

4. Amendment of Section 6, Act XVII of 1975. In the said Act, in

Section 6 for the word "seven hundred and fifty" the words three thousand shall be substituted.

5. Amendment of Section 8, Act XVII of 1975. In the said Act, in

@ for subsection (1) the following shall be substituted, namely:

“(1) The Speaker shall be entitled, without payment of rent to the use of an official residence including accommodation on tour throughout his term of office, and for period of fifteen days immediately thereafter, and the charges for its maintenance including electricity and gas charges shall be borne by Government. The residence shall be furnished by Government at a cost exceeding rupees one lac in case of a building reserved for this purpose at the first term and rupees sixty thousand for any subsequent term.”

(ii) in subsection (2), for the words “one thousand and five hundred the words “eight thousand” shall be substituted; and

(iii) in subsection (3) for the figures “1500” the words “eight thousand shall be substituted.

Amendment of Section 11, Act XVII of 1975.- In the said Act,

in Section 11, for the words “one hundred” the words “one

hundred and twenty five” shall be substituted.

Amendment of Section 15, Act XVII of 1975.- In the said Act, in Section 15, for sub-section (2) for the words “two thousand and five hundred” the word “five thousand” shall be substituted.

Amendment of Section 21, Act XVII of 1975.- In the said Act, in Section 21, for the figure “7500” the words “fifty thousand” shall be substituted.
