ACT

to amend the Azad Jammu and Kashmir Legislative Assembly Speaker (Salary Allowances and Privileges) Act, 1975

WHEREAS it is expedient to amend the Azad Jammu and Kashmir Legislative Assembly Speaker (Salary, Allowances and Privileges) Act, 1975 for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1. Short title and commencement.- (1) This Act may be called the Azad Jammu and Kashmir Legislative Assembly Speaker (Salary, Allowances and Privileges) (Amendment) Act, 2003.

(2) It shall come into force at once and shall be deemed to have taken effect from 1st January, 2003.

2. Amendment of Section 3, Act XVII of 1975. - In the Azad Jammu and Kashmir Legislative Assembly Speaker (Salary, Allowances and Privileges) Act, 1975 (Act XVII of 1975), hereinafter referred to as the said Act, in section 3, for the word "thirty two thousand", the word "Thirty Seven Thousand" shall be substituted.

3. Amendment of Section 7, Act XVII of 1975.- In the said Act, for section 7 the following shall be substituted: -

"7, Transport. The Speaker shall be entitled to the use of two official cars maintained at the Government expense throughout his term and for a period of fifteen days immediately thereafter."

4. Amendment of Section 8, Act XVII of 1975.- In the said Act, in section 8, for the words "seventeen thousand" wherever occurring, the words "twenty five thousand" shall be substituted.

5. Amendment of Section 11 Act XVII of 1975.- In the said Act, in section 11, for the words "at such rate as may be determined

by the finance committee of the Assembly", the words "five hundred and fifty rupees" shall be substituted.

Amendment of Section 15 Act XVII of 1975.- In the said Act, in Section 15,subsection (2), for the words "twenty thousand two hundred and fifty" the word "thirty seven thousand" shall be substituted.

Amendment of Section 20, Act XVII of 1975.- In the said Act, in section 20, for the full stop at the end a colon shall be substituted and thereafter the proviso shall be added: -

"Provided that the liability of Government in respect of the two telephones installed at the residence shall not exceed the amount equal to ten thousand local calls collectively for both the telephones."

Repeal. The Azad Jammu and Kashmir Legislative Assembly Speaker (Salaries Allowances and Privileges) (Amendment) Ordinance, (Ordinance No. XVIII of 2002), is hereby repealed.
