ACT

to amend the Azad Jammu and Kashmir Ministers (Salaries, Allowances and Privileges Act, 1975

WHEREAS it is expedient to amend the Azad Jammu and Kashmir Ministers (Salaries, Allowances and Privileges) Act, 1975 (Act XVIII of 1975) for the purposes hereinafter appearing;

It is hereby enacted as follows: -

1. Short title and commencement. - (1) This Act may be called the Azad Jammu and Kashmir Ministers (Salaries, Allowances and Privileges) (Amendment) Act, 2003.

(2) It shall come into force at once and shall be deemed to have taken effect from 1st January, 2003.

2. Amendment of Section 3, Act XVIII of 1975.- In the Azad Jammu and Kashmir Ministers (Salaries, Allowances and Privileges) Act, 1975 (Act XVIII of 1975), hereinafter referred to as the said Act, in Section 3, for the words "thirty five thousand" and "twenty eight thousand", the words "thirty nine thousand" and "thirty five thousand" shall respectively be substituted.

3. Amendment of Section 8, Act XVIII of 1975.- In the said Act, in section 8, for the words "fifteen thousand", wherever occurring, the words "Twenty thousand" shall be substituted: -

4. Amendment of Section 11, Act XVIII of 1975.- In the said Act, in Section 11, for the words "four hundred and fifty", the words "five hundred and fifty", shall be substituted.

5. Amendment of Section 15, Act XVIII of 1975.- In the said Act, in Section 15, for the words "twenty one thousand", the words "thirty nine thousand" and for the words "eighteen thousand", the words "thirty five thousand" shall be substituted.



Amendment of Section 20, Act XVIII of 1975.- In the said Act, in Section 20, for the full stop at the end a colon shall be substituted and thereafter the following proviso shall be added: -

“Provided that the liability of Government in respect of the two telephones installed at the residence shall not exceed the amount equal to ten thousand local calls collectively for both the telephones:

Provided further that there shall be no calls limit in respect of telephones installed at official residences of the Prime Minister:

Provided further that the Prime Minister shall be entitled to one official telephone at his private residence, both for office and private use, subject to a maximum of ten thousand local calls.”

Repeal. The Azad Jammu and Kashmir Ministers (Salaries, Allowances and \_ Privileges) (Amendment) Ordinance, (Ordinance No. XVII of 2002), is hereby repealed.
