WHEREAS it is expedient to provide for conferment of proprietary Preamble.

rights on Mugarraridars in the [Khyber Pakhtunkhwa];

It is hereby enacted as follows:--

1. (1) This Act may be called the "[Khyber Pakhtunkhwa] Short title Muaarraridars (Conferment of Proprietary Rights) Act, 1995. extend and commencement

(2) It shall extend to the whole of the *[Province of the Khyber Pakhtunkhwa].

(3) It shall come into force at once.

2. (1) | In this Act, unless there is anything repugnant in the subject Definition or context,-

(i) "Government" means the Government of the °[Khyber Pakhtunkhwa];

(ii) "Muqarraridar" means any person who holds land owned or administered by Government and has been entered as Mugqarraridar in the revenue record before the commencement of the '[Khyber Pakhtunkhwa] Tenancy Act, 1950 (Act XXV of 1950), and includes his successors-in-interest;

(iii) "Prescribed" means prescribed by rules made under this Act.

(2) Words and expressions not specifically defined here shall have the same meanings as are assigned to them in the West Pakistan Land Revenue Act, 1967 (W.P. Act XVII of 1967).

3. Notwithstanding anything to the contrary contained in any law for the time being in force, any person entered as Muqarraridars in relation to land owned or administered by Government shall become full owner thereof on payment of compensation to Government at such rate, within such period and on such terms and conditions as may be prescribed.

4. Government may make rules to carry out the purposes of this Act.

5. The Khyber Pakhtunkhwa, Mugarraridars (Conferment of Proprietary Rights) Ordinance, 1995 (Khyber Pakhtunkhwa Ordinance No. I of 1995) is hereby repealed.
