WHEREAS it is expedient further to amend the °[Khyber
Pakhtunkhwa] Province Finance Ordinance, 1982, for the purpose

hereinafter appearing;

It is hereby enacted as follows:—

1. (1) This Act may be called the [Khyber Pakhtunkhwa] Finance
(Amendment) Act, 1985.

(2) It shall come into force at once and shall be deemed to have
taken effect on 1st July, 1984.

2. In the *[Khyber Pakhtunkhwa] Ordinance No. V of 1982, in sub-
section (1) of section 4,-

(a) for the words and figure "at the rate of Rs. 2.50 per maund" the

substituted; and
