Pakhtunkhwa] is not in session and the Governor of the '[Khyber Pakhtunkhwalis
satisfied that circumstances exist which render immediate legislation necessary;

NOW, THEREFORE, in exercise of the powers conferred on him by
clause (1) of Article 135 of the Interim Constitution of the Islamic Republic of
Pakistan, the Governor of the *[Khyber Pakhtunkhwa]is pleased to make and
promulgate the following Ordinance-

1. d) This Ordinance may be called the [Khyber Pakhtunkhwa] Property Short title and
