REGULATION

to provide for the extension of the West Pakistan National Calamities
(Prevention and Relief) Act, 1958, to the Tribal Areas of '[.....-.]
Dera Ismail Khan and Peshawar Divisions.

WHEREAS clause (2) of Article 223 of the Constitution *[1962]
provides that the Governor of West Pakistan with the approval of the President
may, with respect to any matter within the legislative competence of the
Provincial Legislature, make regulations for a Tribal Area or any part of a
Tribal Area situated in the Province;

AND WHEREAS it is expedient to provide for the extension of the
West Pakistan National Calamities (Prevention and Relief) Act, 1958, to the
Tribal Areas of 3 ceeeeeeeeenes] Dera Ismail Khan and Peshawar Divisions;

NOW, THEREFORE, the Governor of West Pakistan, with the
approval of the President, is pleased to make the following Regulation:—

1. (1) This Regulation may be called the West Pakistan National
Calamities (Prevention and Relief Act) (Extension to Tribal Areas) Regulation,
1963.

(2) It extends to the Tribal Areas of "[.....] Dera Ismail Khan and
Peshawar Divisions.

(3) It shall come into force at once.
