AN  
ORDINANCE

to abolish certain fees and cesses in the 3[Khyber Pakhtunkhwa].

WHEREAS it is expedient to abolish certain fees and cesses in the [Khyber Pakhtunkhwa], in the manner hereinafter appearing;

AND WHEREAS the Governor of the \*[Khyber Pakhtunkhwa] is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by Article 128 of the Constitution of the Islamic Republic of Pakistan, read with the Provisional Constitution Order, 1981 (C.M.L.A. Order No. 1 of 1981), the Governor of the °[Khyber Pakhtunkhwa] is pleased to make and promulgate the following Ordinance:

1. (1) This Ordinance may be called the "[Khyber Pakhtunkhwa] Finance Ordinance, 1981.

(2) It shall extend to whole of the \*[Khyber Pakhtunkhwa].

(3) It shall come into force on and from the 1st day of July, 1981.

2. In the [Khyber Pakhtunkhwa] Finance Act. 1973 ('°[Khyber Pakhtunkhwa] Act XII of 1973), section 7 shall be omitted.

3. In the "[Khyber Pakhtunkhwa] Finance Act, 1977 [Khyber Pakhtunkhwa] Act X of 1977), section 7 shall be omitted.
