ACT

to repeal the West Pakistan Tendoo Leaves (Prohibition on Possession and Use) Ordinance, 1966, in its application to the *[Khyber Pakhtunkhwa.]

WHEREAS it is expedient to repeal the West Pakistan Tendoo Leaves Preamble. (Prohibition on Possession and Use) Ordinance, 1966, (W. P. Ord No. XXIV of 1966), in its application to the [Khyber Pakhtunkhwa].

It is hereby enacted as follows: —

1. (1) This Act may be called the West Pakistan Tendoo Leaves Short title and (Prohibition on Possession and Use) ('[Khyber Pakhtunkhwa]) Act, 1974. ;

(2) It shall come into force at once.
