REGULATION

to extend the provisions of the General Clauses Act, 1897, to the *[Tribal] Areas
of West Pakistan.

WHEREAS it is expedient to extend the provisions of the General-Clauses Preamble.
Act, 1897, to the *[Tribal] Areas of West Pakistan for the purposes of the peace and
good government thereof.

NOW, THEREFORE, in pursuance of the Presidential Proclamation of the
seventh day of October, 1958, and having received the previous approval of the
President, the Governor of West Pakistan, in exercise of all powers enabling him in
that behalf, is pleased to make and promulgate the following Regulation : —

1. (1) This Regulation may be called the West Pakistan General Clauses Short title extent
(Extension to “[Tribal] Areas) Regulation, 1961. and
commencement.

(2) It extends to the *[Tribal] Areas of West Pakistan.

(3)It shall come into force at once.

2. The provisions of the General Clauses Act, 1897, shall apply to the “[Tribal] Extension of
Areas of West Pakistan. Act X of 1897.
