Whereas it is expedient to make provisions to give effect to the financial  
proposals of the Federal Government for the year beginning on the first day of July,  
2011. and to amend certain laws for the purposes herein set out appearing:

It is hereby enacted as follows:—

1. Short title, extent and commencement.—(1) This Act may be  
called the Finance Act, 2010,

(2) It extends to the whole of Pakistan.

Cognizance of offences by Special Judges.—(1)

Notwithstanding anything contained in this Act or any other law for the time being in force, a Special Judge may, within the limits of his jurisdiction, take cognizance of any offence punishable under this Act,—

(a) upon a report in writing made by an officer of Inland Revenue or by any other officer especially authorized in this behalf by the Federal Government; or

(b) upon receiving a complaint or information of facts constituting such offence made or communicated by any person; or

(c) upon his own knowledge acquired during any proceeding before him under this Act or under any other law for the time being in force,

Upon the receipt of report under clause (a) of sub-section (1), the Special Judge shall proceed with the trial of the accused.

Upon the receipt of a complaint or information under clause (b), or acquired in the manner referred to in clause (c) of sub-section (1), the Special Judge may, before issuing a summons or warrant for appearance of the person complained against, hold a preliminary inquiry for the purpose of ascertaining the truth or falsehood of the complaint, or direct any Magistrate or any officer of Inland Revenue or any police officer to hold such inquiry and submit a report, and such Magistrate or officer shall conduct such inquiry and make report accordingly.

If, after conducting such inquiry or after considering the report of such Magistrate or officer, the Special Judge is of the opinion that,—

(a) there is no sufficient ground for proceeding, he may dismiss the complaint, or

(b) there is sufficient ground for proceeding, he may proceed against the person complained against in accordance with law.

A Special Judge or a Magistrate or an officer holding inquiry under sub-section {3} may hold such inquiry, as early as possible, in accordance with the provisions of section 202 of the Code of Criminal Procedure, 1898(Act V of 1898).

Special Judge, etc. to have exclusive jurisdiction.—  
Notwithstanding anything contained in this Act or in any other law for the time being in force,—

(a) no court other than the Special Judge having jurisdiction, shall try an offence punishable under this Act;

(b) no other court or officer, except in the manner and to the extent specifically provided for in this Act, shall exercise any power, or perform any function under this Act;

(c) no court, other than the High Court, shall entertain, hear or

decide any application, petition or appeal under chapters XXX and XXXI of the Code of Criminal Procedure, 1898 (Act V of 1898), against or in respect of any order or direction made under this Act, and

(d) no court, other than the Special Judge or the High Court, shall entertain any application or petition or pass any order or give any direction under chapters XXXVII, XXXIX, XLIV or XLV of the aforesaid Code.

Provisions of Code of Criminal Procedure, 1898, to apply.—  
(L) The provisions of the Code of Criminal Procedure, 1898(Act V of 1898), so far as they are not inconsistent with the provisions of this Act, shall apply to the proceedings of the court of a Special Judge and such court shall be deemed to be a court of Sessions for the purposes of the said Code and the provisions of Chapter XXIIA of the aforesaid Code, so far as applicable and with the necessary modifications, shall apply to the trial of cases by the Special Judge under this Act. :

For the purposes of sub-section (1), the Code of Criminal Procedure, 1898(Act V of 1898), shall have effect as if an offence punishable under this Act were one of the offences referred to in sub-section (1) of section 337 of the said Code.

are appointed within the territorial jurisdiction of a High Court, the High Court, and where more than one Special Judge is so appointed, the Federal Government, may, by order in writing direct the transfer, at any stage of the trial, of any case from the court of one Special Judge to the Court of another Special Judge for disposal, whenever it appears to the High Court or, as the case may be, the Federal Government, that such transfer may promote the ends of justice or tend to the general convenience of the Parties or witnesses.

As respects of a case transferred to a Special Judge under sub-section (1), such Special Judge shall not by reason of the said transfer, be bound to recall and rehear any witness whose evidence has been recorded in the case before the transfer and may act upon the evidence already recorded or produced before the court which tried the case before the transfer.

Place of sittings.—A Special Judge shall ordinarily hold sittings at his headquarters but, keeping in view the general convenience of the parties or the witnesses, he may hold sittings at any other place.

Appeal to the High Court.—(i) Any person, including the Federal Government, the Board, the Commissioner or Director of Intelligence and Investigation or any other officer authorized in this behalf by the Board, aggrieved by any order passed or decision made by a Special Judge under this Act or under the Code of Criminal Procedure, 1898 (Act V of 1898), may, subject to the provisions of Chapters XX XI and XXXII of the said Code, within sixty days from the date of the order or decision, prefer an appeal to the High Court.

It is hereby declared accordingly in terms of section 3 of the Act that it is expedient in public interest that the provision of sub-clause (13) of clause 3 shall have effect from 6th June, 2010, whereas the sub-clauses of clause 7, clause 8 and clause 9 mentioned above shall have effect from 6th June, 2010, under the Act.
