Acts, Ordinances, President's Orders and Regulations

Islamabad, the 7th August, 1994.

The following Acts of Majlis-e-Shoora (Parliament) received the assent of the President on the 3rd August, 1994, and are hereby published for general information :—

AcT No. XV OF 1994

An Act further to amend the Dangerous Drugs Act, 1930

WHEREAS it is expedient further to amend the Dangerous Drugs Act, 1930 (II of 1930), for the purposes hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Dangerous Drugs (Amendment) Act, 1994.

(2) It shall come into force at once.

2. Amendment of section 4, Act II of 1930.—In the Dangerous Drugs Act, 1930 (II of 1930), hereinafter referred to as the said Act, in section 4, in sub-section (1),—
(i) in clause (d), the word “raw” shall be omitted ; and

(ji) in clause (€), the word “raw” shall be omitted.

3. Amendment of section 10, Act II of 1930.—In the said Act, in section 10, for sub-section (2) the following shall be substituted, namely :—

“(2) Whoever—

(a) possesses heroin or cocaine in excess of ten grams or opium or coca leaf in excess of one kilogram shall be punished with imprisonment for life or with imprisonment which shall not be less than two years, and shall also be liable to fine; and

(b) _ traffics in, or finances the trafficking of heroin, or cocaine or opium or coca leaf shall be punished with death or with imprisonment for life or with imprisonment which shall not be less than five years, and shall also be liable to fine.”.

4. Amendment of section 13, Act II of 1930.—In the said Act, in section 13, for the words “imprisonment for life or with imprisonment which is not less than two years” the words “death or with imprisonment for life” shall be substituted.

5. Amendment of section 14, Act II of 1930.—In the said Act, in section 14, for the words “imprisonment for life or with imprisonment which is not less than two years” the words “death or with imprisonment for life” shall be substituted.

_6. Omission of section 16, Act II of 1930.—In the said Act, section 16 shall be omitted.

7. Amendment of section 35C, Act II of 1930,—In the said Act, in section 35C, for the word “life” the words “a term for two years or more” shall be substituted.

8. Repeal.—The Dangerous Drugs (Amendment) Ordinance, 1994 (Ordinance No. XII of 1994), is hereby repealed.

AcT No. XVI of 1994

An Act further to amend the Airports Security Force Act, 1975

WHEREAS it is expedient further to amend the Airports Security Force Act, 1975 (LXXVII of 1975), for the purpose hereinafter appearing ;

It is hereby enacted as follows —

1. Short title and commencement.—(1) This Act may be called the Airports Security Force (Amendment) Act, 1994,

(2) It shall come into force at once.

2. Amendment of section 7A, Act LXXVII of 1975.—In the Airports Security Force Act, 1975 (LXXVII of 1975), in section 7A, after sub-section (3), the following new sub-section shall be added, namely :—

“(4) Notwithstanding anything contained in any other law for the time being in force, except the authorities specified in sub-sections (1) and (2) of section 7F, no other authority, tribunal or court shall have jurisdiction to vary, modify; alter, annul, set aside,-revise or review any order passed by any officer of the Force, authorized under the Pakistan Army Act, 1952 (XXXIX of 1952).”.
