The following Acts of Parliament received the assent of the President on the 13th December, 1975, and are hereby published for general information :—

AGT No. LXXVII of 1975

An Act to provide for the constitution and regulation of the Airports
Security Force

Whereas it is expedient to provide for the constitution and regulation of the Airports Security Force for ensuring security of all aerodromes, airports, aircraft and civil aviation installations, and for the maintenance of law and order therein, and for matters connected therewith or ancillary thereto ;

It is hereby enacted as follows :—~

CHAPTER I

1. Short title, extent, application and commencement.—(1) This Act may be called the Airports Security Force Act, 1975.

(2) It extends to all aerodromes and airports, all civil aviation stations, centres or offices in Pakistan, all Pakistan air services and activities relating to civil aviation.

(3) It shall apply to all members and officers of the Force wherever they may be.

(4) It shall come into force at once.

ACT No. LXXVIII of 1975

An Act to amend the Banks (Nationalisation) Act, 1974

WHEREAS it is expedient to amend the Banks (Nationalisation) Act, 1974 (XIX of 1974), for the purposes hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(i) This Act may be called the Banks (Nationalisation) (Amendment) Act, 1975.

(2) It shall come into force at once.

___2. Insertion of new section 5A, Act XIX of 1974,—In the Banks (Nationalisation) Act, 1974 (XIX of 1974), hereinafter referred to as the said Act, after section 5, the following new section shall be inserted, namely :—

“5A. Transfer of powers and functions to Provincial Government—Notwithstanding anything contained in this Act, the Federal Government may, by notification in the official Gazette, direct that, in respect of the Punjab Provincial Co-operative Bank Ltd., such of the

powers and functions of the Federal Government or the Council under this Act as may be specified in the notification shall be exercised and performed by the Government of the Punjab ”.

3. Amendment of section 11, Act XIX of 1974.—In the said Act, in section 11, after sub-section (5), the following new sub-section shall be. inserted, namely :—

“(5A) Where the Council is satisfied that—
(a) in the public interest ; or

(b) to prevent the affairs of any bank being conducted in a manner detrimental to the interests of the depositors or in a manner prejudicial to the interests of the bank; or

(c) to secure the proper management of any bank generally,
Tt is necessary to issue directions to banks generally, or to any bank in particular, it may, from time to time, issue such directions as it deems

fit, and the banks, or the bank, as the case may be, shall be bound to comply with such directions. ”.

4. Repeal—The Banks (Nationalisation) (Amendment) Ordinance, 1975 (XXIII of 1975), is hereby repealed.

ACT No. LXXIX of 1975

An Act to provide for the regulation of the functioning of foreign cultural associations

WHEREAS it is expedient to provide for the regulation of the functioning of foreign cultural associations ;

Tt is hereby enacted as follows :—

1. Short title, extent and commencement.—(1) This Act may be called the Foreign Cultural Associations (Regulation of Functioning) Act, 1975,

(2) It extends to the whole of Pakistan.

(3) It shall come into force at once.

2. Definitions.—In this Act unless there is anything repugnant in the subject or context,—

(a) “foreign cultural association” means an association, by whatever name called, having as its object the promotion of cultural and friendly relations between Pakistan and a foreign country and includes a branch of such association ; and

(b) “prescribed” means prescribed by rules made under section 15.

3. Formation of foreign cultural associations.—(1) No foreign cultural association shall be formed with the object of, or engage itself in, propagating any opinion, or acting in any manner, prejudicial to the ideology, integrity, security, constitution or system of Government of Pakistan or Pakistan's relations with any foreign country or contrary to morality or any law for the time being in force.
