assent of the President on 4th April, 1999, is hereby published for general information —

Act No. 19 of 1999

An Act further to amend the Capital Development Authority Ordinance, 1960

WHEREAS it is expedient further to amend the Capital Development Authority
Ordinance, 1960 (XXIII of 1960), for the purposes hereinafter appearing :

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the
Capital Development Authority (Amendment) Act, 1999. -

{2} It shall come into force at once.

2. Amendment of section 2, Ordinance XXI of 1960,—In the
Capital Development Authority Ordinance, 1960 (XXIII of 1960), hereinafter
referred to as the said Ordinance, in section 2,— ‘

(a) in clause (k), in sub-clause (i), the word “and” at the end, shall be
omitted ; and

(ii), for the full stop at the end a semi-colon and word
“and” shall be substituted and thereafter the following new sub-
clause shall be ‘added, namely :—

“(ii) in relation to land acquired on or after the first day of January,
1996, the market value as may be determined in accordance -
with the provisions of the Land Acquisition Act, 1894 us
applicable in the Province of the Punjab,”

3. Amendment of section 30, Ordinance XXUL of 1960.—In the
said Ordinance, in section 30,—

(a) in sub-section (1), in paragraph first after the word “land” the words
and Figure “on the date of order of its acquisition made under sec-
tion 25” shall be added ; and

(b) after sub-section (2) the following new sub-section shall be added,
namely :—

“(3) In relation to land acquired on or after the first day of January,
1996, in addition to the value of the land determined as
aforesaid, the Deputy Commissioner shall in every case award
a sum of twenty per centum on such value in consideration of
the compulsory nature of the acquisition,”

4, insertion of new section 32A.—In the said Ordinance after
section 32 the following new section shall be inserted, namely :—

“32A, Payment of additional compensation—When the amount of the
compensation determined under section 29 and sub-section (3) of section 30 is not
paid or deposited with the Deputy Commissioner on or before taking possession
of the land, the Deputy Commissioner shall, in addition to such compensation,
pay additional compensation computed at the rate of eight per centum per annum
on such compensation from the time of so taking the possession until it has been
so paid or deposited”,
