The following Acts of Parliament received the assent of the President on the 15th February, 1975, and are hereby published for general information :—

Act No. XXIII OF 1975

~ An Act further to amend the Pakistan Coinage Act

WHEREAS it is expedient further to amend the Pakistan Coinage Act (III of 1906), for the purposes hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.— (1) This Act may be called the Pakistan Coinage (Amendment) Act, 1975.

(2) It shall come into force at once.

2. General.—In the Pakistan Coinage Act (III of 1906), hereinafter referred to as the said Act, for the words “ Central Government ”, wherever occurring, the words “Federal Government” shall be substituted.

3. Amendment of section 6, Act III of 1906.—In the said Act, in section 6,—
(a) after the word “ Mint”, the commas and words “, or at a mint outside Pakistan,” shall be inserted; and

(b) the words “not higher than one rupee” shall be omitted.

4. Amendment of section 13, Act II of 1906.—In the said Act, in section 13.

in sub-section (1), in clause (a), after the words “rupee coin”, the words “or a coin of any higher denomination ” shall be inserted.

An Act to amend the Central “Employees Benevolent Fund and Group Insurance Act, 1969.

WHEREAS it is expedient to amend the Central Employees Benevolent Fund and Group Insurance Act. 1969 (II of 1969), for the purposes hereinafter

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Central Employees Benevolent Fund and Group Insurance (Amendment) Act, 1975.

(2) It shall come into force at once.

2. General amendments, Act II of 1969.—In the Central Employees Benevolent Fund and Group Insurance Act, 1969 (II of 1969), hereinafter referred to as the said Act,—

(a) for the words “Central Government”, wherever occurring, the words “Federal Government” shall be substituted ;

(b) for the words “Central Employees Benevolent Fund”, wherever occurring, the words “ Federal Employees Benevolent Fund” shall be substituted ; and

(c) for the words “Central Employees Insurance Fund”, wherever occurring, the words “Federal Employees Insurance Fund” shall be substituted.

3. Amendment of section 1, Act II of 1969.—In the said Act, in section 1, for the words, comma and figure “Central Employees. Benevolent Fund and Group Insurance Act, 1969” the words, comma and, figure “ Federal Employees Benevolent Fund and Group Insurance Act, 1969” shall be substituted.

4. Amendment of section 2, Act I of 1969.—In the said Act, in section 2,—
(Ay for clause (4),—the fotlowing sha be substituted, namely :—

“ (4) “employee” means,—

(a) any person who is a member of an All-Pakistan Service or of a civil service of the Federation, or who holds a civil post im connection with the affairs of the Federation ;

(b) any person appointed to the secrefarial staff of the National Assembly or of the Senate whose terms and conditions of service are governed by rules or law made under Article 87;

(c) any officer or servant of the Supreme Court whose terms and conditions of eraployment are governed? by reles made under Article 208 ;

(@) any officer or servant employed in connection with the functions
of the Chief Election Commissioner or an Election Commission
whose terms and conditions of employment are governed by
rules or law made under Article 271 ;

(©) any officer or servant of such body corporate, institution, organization or autonomous body, as the Federal Government may, by notification in the official Gazette, specify.

and includes any such person, officer, servant or member of the staff who is—

@ on deputation elsewhere or on foreign service within the meanings of the Fundamental Rules,

(ii) undergoing study or training in or outside Pakistan,

(iii) on leave, or

Civ) under orders of suspension,

but does not include any person who :—~ :

(a) is an employee of the Railways; or

(b) has attained the age of sixty years; or

(c) is an officer or servant of a Provincial Government on deputa-

tion to the Federal Government ;”

(B) in clause (5), in such clause (b), the words “residing with and” shall be omitted ; and

(C) in clause (7), for the commas and words “, technical pay.” the words and comma “and technical pay, but does not include” shall be substituted.

5. Amendment of section 4, Act II of 1969.—In the said Act, in section 4, in sub-section (1),—

(a) for the words “Central Employees Benevolent and Insurance Funds ” the words “Federal Employees Benevolent and Insurance Funds” shall be substituted ; and

(b) in the proviso, for the words “Labour and Social Welfare Division” the words “Labour and Local Bodies Division” shall be substituted.

6. Amendment of section 17, Act II of 1969.--In the said Act, in section 17, in sub-section (5), for the words “families of the employees” the words and commas, “employees, including retired employees, and their families ” shall be substituted.

7. Amendment of section 20, Act II of 1969.—In the said Act, in section 20, for the words “Comptroller and Auditor-General of Pakistan”, twice occurring, the words “ Auditor-General of Pakistan” shall be substituted.

8. Amendment of First Schedule, Act II of 1969.—In the said Act. in the First Schedule, for the word “drawing” the words “whose pay last drawn was at the monthly rate of” shall be substituted.

9. Amendment of Second Schedule, Act II of 1969.—In the said Act, in the Second Schedule,—

(a) for the word “receiving” the words “whose pay last drawn was at

the monthly rate of" shall be substituted : and

(b) the words "per mensem" shall be omitted.
