Act No. I or 1985

An Act to give effect to the financial proposals of the Federal Government for
the year beginning on the first day of July, 1985. and to amend certain laws
WHEREAS it is expedient to make provisions to give effect to the financial
proposals of the Federal Government for the year beginning on the first day of
July, 1985, and to amend certain laws for the purposes hereinafter appearing
It is hereby enacted as follows :—

1. Short title and extent.—(1) This Act may be called the Finance Act, 1985.
(2) It extends to the whole of Pakistan.

2. Amendment of Act XV of 1963.—The following amendments shall be
made in the Wealth Tax Act, 1963 (XV of 1963), namely :—

(1) in section 2,—
(a) in clause (e),—
(i) in sub-clause (i), after the semi colon at the end. the word
“and” shall be added ;

An Act further to amend the Chairman and Speaker (Salaries, Allowances and
Privileges) Act, 1975

WHEREAS it is expedient further to amend the Chairman and Speaker
(Salaries, Allowances and Privileges) Act, 1975 (LXXXH of 1975), for the pur-
poses hereinafter appearing ;

It is hereby enacted as follows :~—

1, Short title and commencement.—(i) This Act may be called the Chair-
man and Speaker (Salaries, Allowances and Privileges) (Amendment) Act, 1985.

(2) It shall come into force at once and shall be deemed to have taken
effect on the first day of March, 1985.

7 2. Amendment of section 3, Act LXXXII of 1975.—In the Chairman and

“(1A) The assessed rent of. house, hired for the use of the Chairman
or the Speaker shall in no case 'exceed eight thousand Tupees per
