S An Act further to amend the Suppression of Terrorist Activities

(Special Courts) Act, 1975

WHEREAS it is expedient further to amend the Suppression of Terrorist Activities (Special Courts) Act, 1975 (XV of 1975), for the purpose hereinafter appearing ; :

It is hereby enacted as follows :—

1. Short tile and commencement.—(1) This Act may be called the Suppression of Terrorist (Special Courts) (Amendment) Act, 1991.
(2) It shall come into force at once.
2. Amendment of Schedule, Act XV of 1975.—In the Suppression of Terrorist Activities (Special Courts) Act, 1975, in the Schedule, in paragraph (a), in sub paragraph (i) after the figures letter and comma "124A," the figure, letter and comma "365A," shali be inserted and shall be devmed to have been so inserted on the third Boon OR of a.
