Act No, XVI oF 1991

An Aet further to amend the Pakistan Penal Code, 1860 and the Code of Criminal Procedure, 1898

WHEREAS it is expedient further to amend the Pakistan Penal Code (Act XLV of 1860), and the Code of Criminal Procedure, 1898 (Act V of 1898) for the purposes hereinafter appearing;

[tis hereby enacted as follows :—

1, Short title and commencement.—(1) This Act may be called the Criminal Law (Second Amendment) Act, 1991, bins

2. Amendment of Section 295A, Act XLV of 1860.—In the Pakistan Penal Code (Act XLY of 1860), in section 295A, for the words “two years” the words “ten years” shall be substituted.

3. Amendment of Schedule If, Act V of 1898.—In the Code of Criminal Procedure, [898 (Act V of 1898), in Schedule I, in column I, in the entries relating to section 295A, in colutin 7, for the figure “2” the figure “10” shall be substituted.

Act No. XVII oF 1991

An Act further to amend the Companies Ordinance, 1984

WHEREAS it is expedient further to amend the Companies Ordinance, 1984 (XLVI of 1984), for the purpose hereinafter appearing;

It is heteyb enacted as' follows —

I, Short title and commencement,—(1) This Act may be called the Companies (Amendment) Act, 1991,

(2) It shall come into force at once.

2. Amendment of section 2, Ordinance XLVII of 1984.—In the Companies Ordinance, 1984 (XLVII of 1984),in seetion 2, in sub-section (1), for clause (15A) the following shall be substiuted and shall be deemed always to have been so substituted, namely :—

“1SA) “financial institutions” means an institution not less than fifty per cent of the share capital of which is held by the Federal Government ora Provincial Government, whether directly or through a company or corporation set up or controlled by such Government, and includes such other institutions or companies as the Federal Governmen! may, by notification in the official Gazette, specify for the purpose;”,

Act No. XVIII of 1991

An Act to establish a Pakistan Telecommunication Corporation

WHEREAS it is expedient to establish a Pakistan Telecommunication Corporation and to provide for matters connected therewith or incidental thereto;

It is hereby enacted as follows :—

1. Short title, extent and commencement.—(1) This Act may be called the Pakistan Telecommunication Corporation Act, 1991.
