The following Acts be Parliament received the assent of the President on the 16th August, 1974, and are hereby published, for general information :—

ACT No. XLII of 1974

An Act to amend the Pakistan Maritime Shipping (Regulation and Control) Act, 1974.

Whereas it is expedient to amend the Pakistan Maritime Shipping (Regulation and Control) Act, 1974 (XVIII of 1974), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Pakistan Maritime Shipping (Regulation and Control) (Amendment) Act, 1974.

(2) It shall come into force at once.

2. Amendment of section 7, Act XVII of 1974.—In the Pakistan Maritime Shipping (Regulation and Control) Act, 1974 (XVIII of 1974), in section 7, after sub-section (4), the following new sub-section shall be added, namely :—

“(s) At any time when the office of Chairman is vacant or the Chairman is absent or is unable to perform the functions of his office due to any other cause, the Federal Government may appoint any member of the Board to act as Chairman until a Chairman is appointed or, as the case may be, the Chairman resumes his functions. ”.

3. Repeal.—The Pakistan Maritime Shipping (Regulation and Control) (Amendment) Ordinance, 1974 (VII of 1974), is hereby repealed.

ACT No. XLIII of 1974

An Act further to amend the Dangerous Cargoes Act, 1953

WHEREAS it is expedient further to amend the Dangerous Cargoes Act, 1953 (V of 1943), for the purposes hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Dangerous Cargoes (Amendment) Act, 1974.

(2) It shall come into force at once.

section 2, Act V of 1953.—In the Dangerous Cargoes Act,

2. Amendment of

1953 (V of 1953), hereinafter referred to as the said Act, in section 2, in clause (1),

(a) in sub-clause (a), for the word * Stowage TM the word ~ Storage ” shall be substituted ; and

(b) for sub-clause (c) the following shall be substituted, namely :—

“(c) prohibited dangerous goods. that is to say, goods classified as”

dangerous in the International Maritime Dangerous Goods Code or the Government Stowage Instructions as revised from time to time by the Federal Government: or”.

3. Amendment of section 5, Act V of 1953.—In the said Act, in section 5, for the words “Commander-in-Chief of the Pakistan Navy” the words “Chief of the Naval Staff” shall be substituted.

4. Amendment of section 6, Act V of 1953.—In the said Act. in section 6, for the words “ Commander-in-Chief of the Pakistan Navy ” and the word “ Commander-in-Chief ” the words “ Chief of the Naval Staff” shall be substituted.

5. Amendment of section 7, Act V of 1953.—In the said Act, in section 7,—

(a) for the words “ Commander-in-Chief of the Pakistan Navy ” and the word “ Commander-in-Chief ” the words “Chief of the Naval Staff” shall be substituted ;

(b) for the words “Captain-in-Charge or to the Naval Officer-in-Charge of the port” the words and commas “ Commodore-in-Charge or Flag Officer Commanding. Karachi. as the case may be” shall be substituted ; and «

(c) for the words “Naval Officer-in-Charge ” occurring for the second time the words and commas ~ officer of the Pakistan Navy, howsoever designated. who is for the time being incharge” shall be substituted.

6. Insertion of new section 8A, Act V of 1953.—In the said Act. after section 8, the following new section shall be inserted, namely :—

“8.A. Technical Adviser Dangerous Cargoes.—The Federal _ Government

(2) The Technical Adviser Dangerous Cargoes shall, besides advising the Federal Government on matters relating to safety and security of any port. prevention of, and dealing with, explosions and fires on vessels carrying dangerous cargoes within the limits of any port and the transit, working and storage of dangerous cargoes, exercise such powers and perform such functions as may be assigned to him by the Federal Government. ”.

7. General amendment, Act V of 1953.—In the said Act, for the words “Central Government”, wherever occurring, the words “ Federal Government ” shall be substituted.

8. Repeal.—The Dangerous Cargoes (Amendment) Ordinance, 1974 (X of 1974), is hereby repealed.
