The following Act of Parliament received the assent of the President on the  
25th June, 1985, and is hereby published for general information :--

An Act to give effect to the financial proposals of the Federal Governimem for  
the year beginning on the first day of July, 1985. and te amend ceriait: laws  
WHEREAS it is expedient to make provisions to give effect to the financial  
proposals of the Federal Government for the year beginning on ihe first day of  
July, 1985, and to amend certain laws for the purposes hereinafter appearing  
Tt is hereby enacted as follows :—

1, Short title and extent.—(1)} This Act may be called the Finance Act, 1985.

(2) Tt extends to the whole of Pakistan.

2. Amendment of Act XV of 1963.--The following amendments shall be  
made in the Wealth Tax Act. 1963 (XV of 1963), namely :—

(1) in section 2,—

(a) in clause (e),—

fi) in sub-clause (i), after the semi colon at the end. the word

“and” shall be added ;

per mile" the words "one rupee and fifty paisa per kilometre", and  
for the words "fifty rupees" the words "one hundred and \_\_\_ fifty -  
rupees" shall be substituted.

7. Amendment of section 17, Act LXXXII of 1975,—In the said Act, in

section 17, in sub-section (2), for the words "four thousand rupees" the words  
"seven thousand rupees" shall be substituted.

An Act further to amend the Deputy Chairman and Deputy Speaker (Salaries,  
Allowances and Privileges) Act, 1975

WHEREAS it is expedient further to amend the Deputy Chairman and  
Deputy Speaker (Salaries, Allowances and Privileges) Act, 1975 (LXXXIII of  
1975), for the purposes hereinafter appearing :

It is hereby enacted as follows :—

1, Short title and commencement,—(1) This Act may be called the Deputy  
Chairman and Deputy Speaker (Salaries, Allowances and Privileges) (Amend-  
ment) Act, 1985.

(2) It shall come into force at once and shall be deemed to have had effect on the first day of March, 1985.

2. Amendment of section 3, Act LXXXI of 1975.—In the Deputy Chairman and Deputy Speaker (Salaries, Allowances and Privileges) Act, 1975 (LXXXI of 1975), hereinafter referred to as the said Act, in section 3, for the words “three thousand rupees” the words “six thousand rupees” shall be substituted.

3. Amendment of section 4, Act LXXXII of 1975.—In the said Act, in section 4, for the words “one thousand and five hundred rupees” the words “four thousand rupees” shall be substituted,

4. Amendment of section 6, Act LXXXIII of 1975.—In the said Act, in section 6, for the words “six hundred rupees” the words “two thousand rupees” shall be substituted.

5. Amendment of section 8 Act LXXXIV of 1975.—In the said Act, in section 8,—

(a) in sub-section (1), for the proviso the following shall be substituted, namely :—

“Provided that half of the electricity and gas charges in excess of seven hundred and fifty rupees per mensem shall be paid by the Deputy Chairman, or as the case may be, the Deputy Speaker.”

(b) after sub-section (1), amended as aforesaid, the following new sub-section shall be inserted, namely :—

“(1A) The assessed rent of a house hired for the use of the Deputy Chairman or the Deputy Speaker shall in no case exceed seven thousand rupees per mensem.” ;

(c) in sub-section (2), for the words “twenty thousand rupees” the words “fifty thousand rupees” shall be substituted ;

(d) in sub-section (3), for the words “one thousand rupees” the words “seven thousand rupees” shall be substituted ; and

(e) in sub-section (4) for the words “one thousand rupees” the words “seven thousand rupees” shall be substituted.

6. Amendment of section 9, Act LXXXIH of 1975.—In the said Act, in section 9,— ‘

(a) in sub-section (2), in clause (b), for the words “ fifty rupees ” the words “one hundred and fifty rupees”, and for the words “twenty-five rupees” the words “seventy-five rupees”, shall be substituted ;

(b) in sub-section (3), in clause (b), for the words “fifty rupees” the words “one hundred and fifty rupees”, and for the words “twenty-five rupees” the words “seventy-five rupees”, shall be substituted; and

(c) in sub-section (5), for the words “one rupee per mile” the words “two rupees per kilometre”, for the words “seventy-five paise per mile” the words “one rupee and fifty paise per kilometre”, and for the words “fifty rupees” the words “one hundred and fifty rupees”, shall be substituted.

7. Amendment of section 17, Act LXXXUI of 1975.—In the said Act, in section 17, in sub-section (2), for the words “three thousand rupees ” the words “six thousand rupees” shall be substituted. ,
