NATIONAL ASSEMBLY OF PAKISTAN
Islamabad, the 9th February, 1973

The following Acts of the National Assembly received the assent of the President on the 9th February, 1973, and are hereby published for general

information :—
ACT No. XXIE of 1973

An Act further to amend the West Pakistan Industrial and Commercial Employment (Standing Orders) Ordinance, 1968.

WHEREAS it is expedient further to amend the West Pakistan Industrial and Commercial Employment (Standing Orders) Ordinance, 1968 (West Pakistan Ordinance No. VI of 1968). for the purposes hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the West Pakistan Industrial and Commercial Employment (Standing Orders) (Amendment) Act, 1973.

(2) It shall come into force at once.

2. Amendment of section 1, W.P. Ordinance No. VI of 1968.—In the West Pakistan Industrial and Commercial Employment (Standing Orders) Ordinance, 1968 (W.P. Ordinance No. VI of 1968), hereinafter referred to as the said Ordinance in section 1. in sub-section (4),

(a) for clauses (a) and (b) the following shall be substituted, namely :—

“(a) every industrial establishment or commercial establishment wherein

“ACT No. XXV 0 or 1973

An Act tv amend the Economic Reforms Order, 1972

WHEREAS it is expedient to amend the Economic Reforms' Order, 1972
(P. O. No. I of 1972);

It is hereby enacted as follows :—

1. Short title and commencement.—(1) ‘This Act may be called the
Economic Reforms Order (Amendment) Act, 1973.

(2) It shall come into force at once.

2. Amendment of Article 4, P. O. No. 1 of 1972.—In the Economic
Reforms Order, 1972 (P. O. No. 1 of 1972), in Article 4, in clause (2), after the
ward “function” at the end, the words and commas “and, on and from such
date as the Federal Government may. by notification in the official Gazette,
specify, the establishment shall be known by such new name as may be so speci-
fied ” shall be added.

3. Repeal.—The Economic Reforms Order (Amendment) Ordinance, 1972
({LXIV of 1972), is hereby repealed.

ACT No. XXVI oF 1973

An Act to amend and consolidate the laws relating to registration and training of
nurses, midwives and health visitors.

WHEREAS it is expedient to amend and consolidate the laws relating to re-
gistration and training of nurses, midwives and health visitors and to provide for
matters ancillary thereto ;

It is hereby enacted as follows :--

1. Short title, extent and commencement.—(i) This Act may be called the
Pakistan Nursing Council Act, 1973.

(2) It extends to the whole of Pakistan.

(3). It shall come into force at once.

2. Definitions.—In this Act, unless there is anything repugnant in the sub-
ject or context,—

(a) “Board” means a Provincial Nursing Examination. Board: constitut-
ed under section 11 ;

(b) “Council” means the Pakistan Nursing Council established under
section 3 ;

(c) “member” means a member of the Council ;

(d) “prescribed” means prescribed by regulations made under section
