The following Acts of Majlis-e-Shoora (Parliament) received the assent of the President on the 8th November, 1987, and are hereby published for general information :—

Acr No, TX or 1987

An Act further to amend the Suppression of Terrorist Activities (Special Courts) Act, 1975.

WHEREAS it is expedient further to amend the Suppression of Terrorist Activities (Special Courts) Act, 1975 (XV of 1975), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Suppression of Terrorist Activities (Special Courts) (Amendment) Act, 1987.

(2) It shall come into force at once,

2, Amendment of Schedule, Act XV of 1975.--In the Suppression of Terrorist Activities (Special Courts) Act, 1975 (XV of 1975), in the Schedule, in paragraph (a), after sub-paragraph (ii), the following new sub-paragraph shall be inserted, namely :—

“(iia) section 302 or section 307, if committed in the course of the same

transaction in which an offence specified in this paragraph or paragraphs (b) and (c) is committed, or in addition to, or in combination with, such offence ;*

(b) in sub-section (2), after the words " publisher who", the commas and word " ,or recording company which," shall be inserted.

9. Amendment of section 8, Act LIV of 1973,—In the said Act, in section 8, in sub-section (2),—

{a) for clause (a) the following shall be substituted, namely :—

"{a) the inspection of the copies and records of the Holy Quran

printed or, as the case may be, prepared before the commencement of this Act;" ;

(b) in clause (b), after the word "copies", the words "and records" shall be inserted ;

(c) in clause (c),—

(i) after the word "copies", the words "and records" shall be inserted ; and

(ii) after the word " publisher", the words " or recording company " shall be inserted ; and

{d) in clause (d)—

(i) after the word "copies", the words "or records" shall be inserted ; and

(i) after the word " print" at the end, the words "or record" shall be added.

An Act further to amend the Emigration Ordinance, 1979

WHEREAS it is expedient further to amend the Emigration Ordinance, 1979 (XVI of 1979), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Emigration (Amendment) Act, 1987,

2, Insertion of new Section 24A, Ordinance KXVHE of 1979,—In the Emigration Ordinance, 1979 (XVIII of 1979), after section 24, the following new section shall be inserted, namely :—

“24A.—A appeal—(1) A person sentenced by a Special Court may, within forty-five days of the order, prefer an appeal to the High Court,

— (2) Where a Special Court has passed an order of acquittal,—

(a) the Federal Government may direct any of its Law Officers to present an appeal ; and

(b) in the case of a prosecution for any offence punishable under this Ordinance, the person in respect of whom the offence is alleged to have been committed may, within a period of forty-five days, appeal,

to the High Court against the order. ”-

An Act further to amend the Charitable and Religious Trusts Act, 1920

WHEREAS it is expedient further to amend the Charitable and Religious Trusts Act, 1920 (XIV of 1920), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Charitable and Religious Trusts (Amendment) Act, 1987.

(2) It shall come into force at once,

2. Substitution of section 12, Act XIV of 1920.—In the Charitable and Religious Trusts Act, 1920 (XIV of 1920), for section 12 the following shall be substituted, namely :—

“ 12.—A appeal—Any person aggrieved by an order passed, or direction given under this Act, may, within ninety days of the date of such order or direction prefer an appeal to the High Court.”

An Act to amend the Prevention of Gambling Act, 1977

WHEREAS it is expedient to amend the Prevention of Gambling Act, 1977 (XXVII of 1977), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title, extent and commencement—(1) This Act may be called the Prevention of Gambling (Amendment) Act, 1987.
