ACT_No. [X of 1985

An Act further to amend the Representation of the People Act, 1976

WHEREAS it is expedient further to amend the Representation of the People
Act, 1976 (LXXXV of 1976), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the
Representation of the People (Seventh Amendment) Act, 1985.

(2) It shall come into force at once.

2. Amendment of section 64, Act LXXXV of 1976.—In the Representation
of the People Act, 1976 (LXXXV of 1976), in section 64, after the word
“sections”, the figure and comma “476,” shall be inserted.

3. Repeal.—The Representation of the People (Seventh Amendment) Ordinance, 1985 (XXIV of 1985), is hereby repealed.

It is hereby enacted as follows :—

1. Short title and commencement,—(i) This Act may be called the Modarabane and Modaraba (Floatation and Control) (Second Amendment) Act,

(2) It shall come into force at once.

2. Amendment of section 5, Ordinance XXXI of 1980.—In the Modaraba Companies and Modaraba (Floatation and Control) Ordinance, 1980 (XXXI of 1980), in section 5, in clause (b), for the words “ five million” the words “two and a half million” shall be substituted. -

An Act further to amend the Employee's Cost of Living (Relief) Act, 1973

WHEREAS it is expedient further to amend the Employees' Cost of Living (Relief) Act, 1973 (1 of 1974), for the purpose hereinafter appearing ;-

It is hereby enacted as follows :—

\, Short Gide and commencement'.—(1) This Act may be called the Employees' Cost of Living (Relief) (Amendment) Act, 1985,

(2) It shall come into force at once.

2. Amendment of section 3, Act I of 1974,—In the Employees' Cost of Living (Relief) Act, 1973 (1 of 1974), in section 3,—

{a} in sub-section (5), in the Explanation, after the word “ sub-section ”, the words, brackets and figure “and sub-section (6)” shall be

(b) after sub-section (5), amended as aforesaid, the following new sub-section shall be added, namely :— .

© (6) In addition to the cost of living allowance admissible uader sub-sections (1), (2), (3) and (4), or, as the case may be, sub-section (5), if any, every employee whose wages do not exceed one thousand five hundred rupees shall, in respect of his employment on or after the first day of July, 1985, whether on time-work or piece-work basis, be paid by his employer an increase in wages at the rate of 13.5 per cent of his wages:

Provided that ie said increase in wages shall be set off—

{a} against the amount payable as a relief due to rise in the cost of living under an agreement or settlement reached, or an award given, under the Industrial Relations Ordinance, 1969 (XXIII of 1969), which has been announced and become effective on or after the first day of January, 1984; and

(b) against the amount payable under an agreement or settlement reached and in force on the first day of July, ne under which employees get increases at regular intervals the basis of a rise in the cost of living:

Provided further that the proyisions of section 7 shall not apply to the increase in wages payable under this subsection. *.

WaerEAs it is expedient further to amend the Pakistan International Airlines Corporation Act, 1956 (XIX of 1956), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short Gide and commencement—i{1) This Act may be called the Pakistan International Airlines Corporation (Amendment) Act, 1985.

(2) Tt shall come into force at once.

2. Amendment of section 25, Act XEX of 1956.—In the Pakistan International Airlines Corporation Act, 1956 (XIX of 1956), in section 25, in sub-section (4), after the words “Federal Government”, the commas and words “, whether by itself or together with any financial institution, banking company, insurance corporation or statutory corporation owned, managed or controlled by it,” shall be inserted,

ACT No. XVI or 1985

An Act further to amend certain laws relating to the welfare of workers

WHEREAS it is expedient further to amend certain laws relating to the welfare of workers ,

It is hereby enacted as follows :—

1, Short fife, extent and commencement—(1) This Act may be called the Labour Laws (Amendment) Act, 1985,

(2) It extends to the whole of Pakistan.

(3) It shall come into force at once.

2. Amendment of certain laws.—The laws specified in the Schedule shall be amended to the extent and in the manner specified in fourth column thereof,
